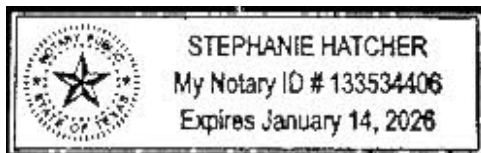

Falcons’ hype train already off track

ATLANTA – For first impressions, what a nightmare.

The Atlanta Falcons supplied so much hope and hype in luring Kirk Cousins to town in March with a massive \$180 million contract. For those type of bucks, with \$100 million guaranteed on a four-year deal, prayers are supposed to be answered.

Instead, Cousins looked too much like his discarded predecessors, Desmond Ridder and Marcus Mariota, as he stumbled and bumbled during his debut in a Falcons uniform.

What an embarrassment. “We know he has to play better,” Falcons coach Raheem Morris said, making his debut, too, with the 18-10 setback to the Pittsburgh Steelers. “There’s no doubt about that. I look forward to him bouncing back from a rough game and a rough outing. I’m not overly concerned about it.”

Sure, it was one week, one game. Overreactions can be more intense than usual in Week 1. It was the first live game action for the quarterback since Cousins, 36, tore his Achilles tendon last October. The rust showed.

Yet the two ugly picks can’t be ignored. The first one, by safety DeShon Elliott, came on the second series in the first quarter, when Cousins said he tried to throw the ball away over the middle as receiver Drake London seemingly stopped running his route. The next one was even worse, near midfield with under three minutes to play and Atlanta looking to go ahead with a touchdown. Cousins, under heavy pressure, threw a wobbly pass toward Ray-Ray McCloud III that Donte Jackson stepped in front of to set up the last of Chris Boswell’s six field goals.

“Just couldn’t get anything on the ball,” said Cousins, who finished the game 16-for-26 for 155 yards, with a paltry 59.0 passer rating.

It wouldn’t get better as the game pro-

gressed. The Falcons were shut out in the second half.

“Need to play better,” Cousins said. “That’s the bottom line.”

The Falcons lost to a team that didn’t score a touchdown while managing just 10 points of their own from an offense with so many first-round weapons. It went deeper than the quarterback merely getting off on the wrong foot. The pass protection was so suspect, allowing T.J. Watt and several of his defensive brethren to consistently harass and pummel Cousins, who was sacked twice and hit seven other times.

The pressure was even more glaring, given how the Falcons need to protect a quarterback never known for his mobility. While Steelers quarterback Justin Fields escaped several would-be sacks and kept plays alive with his legs (and threw for 1 more yard, with no turnovers), that’s hardly the formula for Cousins.

For Cousins to succeed, he needs a clean pocket and precise timing. Connect the dots. That surely wasn’t the case at Mercedes-Benz Stadium on Sunday, and especially on the money downs as Atlanta converted just 2 of 9 third downs (22%).

The Steelers knew. Pittsburgh kept Cousins in check largely with a four-man

rush, wary of his knack for beating blitzes. Along the way, the Steelers exposed pass-protection issues.

“We had to create pressure in a non-blitz structure,” Steelers coach Mike Tomlin said. “We know that about him. Last year, he was good against five or more rushers. Over the course of his career, he’s great against five or more rushers. He’s been good against us, specifically, against five or more rushers. That wasn’t our agenda. We needed to do it with four, and we were able to do that. We were able to pace him. We were able to get him off his spot.”

Watt certainly had a key role in disrupting the timing. The All-Pro linebacker notched a sack, two tackles for losses, three quarterback hits and a fumble recovery – and had two other sacks that caused fumbles, including one that he recovered, wiped out by penalties.

Yet the timing issues were more widespread than that. The most glaring example came just after halftime, when a shotgun snap caromed off tight end Charlie Woerner as he ran in motion. The fumble, recovered by Watt, led to a field goal.

“The timing was off,” Cousins said, blaming himself for asking for the ball off the motion. “It’s my fault. It’s something

that you have to bat 1,000 and you can’t have a mistake, and we paid for it today.”

Cousins was one of 10 quarterbacks across the NFL pegged to start in Week 1 who didn’t play a snap during the preseason. It’s fair to wonder whether some of the timing issues evident in the Falcons’ opening act – when they totaled just 226 yards of offense – might have been reduced had Cousins played during the preseason. Remember, Cousins lobbied Morris to play during the exhibition slate, but the idea was flatly rejected.

“I think the key is that we’re healthy for Week 1 and that was really the focus,” Cousins said of the preseason inactivity. “There’s never excuses. You have to be ready when your number is called.”

The Falcons surely weren’t ready to start their new era with a bang. The omen may have come with Cousins’ first pass, which was way wide of intended receiver Darnell Mooney (one catch, 15 yards) and hit Jackson, the Steelers cornerback, in the chest before falling incomplete. Timing or just a bad throw?

Morris, who replaced Arthur Smith, downplayed a question about his approach in preserving key players during preseason. The Kansas City Chiefs, for example, got exhibition snaps for Super Bowl MVP Patrick Mahomes (although they also lost recently acquired receiver Marquise “Hollywood” Brown to a shoulder injury) and other key players. And the Steelers played several starters during their third preseason game. Conversely, Morris is far from the only NFL coach to put key players in bubble wrap during the preseason.

“I’m not really concerned about that,” Morris said. “I think that is especially about mitigating injuries. So, we wouldn’t be playing nothing but 10 snaps anyway, if we did play. I don’t even value that as much as you do.”

In any event, it doesn’t get any easier. After a Monday night clash at the Philadelphia Eagles – and hey, Cousins is 3-10 on Monday nights – the Falcons host the two-time defending champion Kansas City Chiefs in a prime-time game in Week 3.

In other words, the hype and hope could sure use some better bang for the bucks.

Browns’ Watson problem is getting worse

CLEVELAND – The next time Jimmy and Dee Haslam are mingling with their fellow billionaires, someone should ask them their worst buyer’s remorse.

If the answer isn’t the contract of Cleveland Browns quarterback Deshaun Watson – price tag of \$230 million, results valued at about \$2.30 – then the team’s owners really are playing a different ballgame than everyone else.

When the Haslams acquired Watson from the Houston Texans, they looked past the dozens of sexual assault and inappropriate conduct accusations that had been levied at him.

They fully guaranteed him a deal after years of losing left them on despair’s doorstep, even when 2018 No. 1 pick Baker Mayfield’s initial success stalled. Instead, Watson has played sparingly and been uninspiring when he is on the field, never more so than Sunday’s 33-17 loss to the Dallas Cowboys to begin the team’s 2024 season.

Hours earlier, the opposing quarterback, Dak Prescott, became the highest-paid man in NFL history at \$60 million annually over the next four years; he was guaranteed the most money, too, beating Watson by \$1 million.

Cleveland passed the first-down marker once in the first half and the

Browns were booed entering the locker room at halftime in a 20-3 hole. Watson was 7 of 15 with 36 passing yards. He finished the game averaging 3.8 yards per attempt and didn’t complete a pass beyond 6 yards past the line of scrimmage in the first half.

Both tackles – Jack Conklin and Jedrick Wills Jr. – being ruled inactive meant Watson and the Browns knew it could be a long day against the Dallas defense, which is one of the most talented units in the league. Watson took six sacks, was hit 17 times and spent the late afternoon running for his life.

Nick Chubb is still recovering from last year’s knee injury suffered in the second game of last season and would help balance a scheme that relies on the run game.

The entire Browns’ offensive operation didn’t appear cohesive. Cleveland called its first timeout not even six minutes into the game before coach Kevin Stefanski opted for a field goal try. The team later burned a timeout 2 minutes and 37 seconds into the third quarter.

During garbage time, Watson nearly connected with Amari Cooper on a deep pass that would have been a touchdown. It was a representation of how the game went for Watson – him waiting to be pummeled by an incoming Cowboys defender and hoping that by throwing it up he would be rewarded.

“We’re not the type of people that make excuses,” Watson said. “So some people can say that can contribute to a lot – my injury, guys missing time. But at

the end of the day, once you’re on the field, you gotta perform. You gotta execute. We didn’t do that, overall. And yeah, it showed.”

Watson finished 24-for-45 with 169 passing yards, one TD and two interceptions – one certainly not his fault, as receiver Elijah Moore should have caught the ball that went through his hands. He carried five times for 39 rushing yards. Several of his deep passes weren’t in the vicinity of a Browns receiver.

It was Watson’s 13th game quarterbacking the Browns in his third season with the team.

He served an 11-game suspension after the NFL’s investigation into the sexual assault claims in 2022, and that came

after he sat out the 2021 season while feuding with the Texans. Injuries cost him two-thirds of last season, and the Browns were the AFC’s top wild-card seed without him (though they went 5-1 in the games started by Watson).

In his final season with the Texans, he averaged 8.9 yards per attempt and threw for 4,823 yards. He finished both abbreviated Cleveland campaigns at 6.5 yards per attempt.

The cap hit for Cleveland to move on from Watson after this season is north of \$172 million, according to Over The Cap, which would represent more than two-thirds of this year’s \$255 million allotment for each team.

The Browns are, effectively, tied to him, with looming cap hits of \$72.9 million in each of the next two seasons. Watching Mayfield go 24 of 30 with 289 passing yards and four TDs for the Tampa Bay Buccaneers made Sunday only more painful for the Browns fans who hope this year will be different and build on the successes of 2023.

A Week 10 victory over the Baltimore Ravens on the road last season gave Watson his first signature win with Cleveland. The good feelings didn’t last long. He suffered a season-ending injury that day, and the Joe Flacco Experience commenced.

This offseason, Watson was on a throwing program of sorts and exerted his shoulder sporadically as it healed.

The problem for the Haslams, the Browns and their fans is that a healthy Watson hasn’t been a positive for them.

Alex Palou rolls to third IndyCar title

LEBANON, Tenn. — Alex Palou’s quest to win a third NTT InydCar Series championship in four years was settled early in the season-ending Big Machine Music City Grand Prix at Nashville Superspeedway.

Will Power, the only driver with any hope of unseating Palou as the IndyCar points standings leader, encountered trouble with his seat belts on lap 12 of the 206-lap race Sunday. The extensive repairs, which included reattaching the main harness, kept Power in the pits so long that he fell behind by five laps.

By the time Power returned to the race he was out of contention, meaning all Palou, 27, had to do was finish to secure the championship. Palou finished 11th.

“When I saw (Power) going to pit lane, at first I was like, ‘Oh, what strategy are they going to do?’” Palou said. “Unfortunately, that’s not the way. Obviously, you don’t want your biggest competitor to go down that way in the season finale. It was very dangerous

what happened to him. But that’s what happened to us two weeks ago (at Milwaukee with engine problems). It’s racing, it’s motor sports, it’s what makes this sport so hard.”

It was the 16th champion for Chip Ganassi Racing.

Palou joined an elite group of drivers who won three titles in four years including Sebastian Bourdais (2004-07), Jimmy Bryan (1954, 1956-57), A.J. Foyt (1960-61, 1963-64), Dario Franchitti (2009-II) and Rick Mears (1979, 1981-82).

“Alex’s name now has to be included with the best drivers ever,” Ganassi said. “He is in with a pretty elite group. He’s in rarefied air.”

Palou won approximately \$1 million for the championship. He won three races and had 14 top-5 finishes in 24 starts this season.

Colton Herta won the race Sunday, his first victory on an oval, and moved up to second in the final season standings. It was the ninth career win for Herta, 24. Pato O’Ward finished second and Josef Newgarden third in the race.

Buescher wins thriller in OT at Watkins Glen

A mere two weeks ago, Chris Buescher dealt with the heartbreak of just missing the NASCAR Cup Series playoffs. On Sunday at Watkins Glen International, Buescher was able to get some redemption.

Buescher won The Go Bowling at The Glen, the second race of the 10-race Cup Series playoffs, taking the checkered flag in an eventful race that culminated in a thrilling overtime battle.

Buescher had surged to the lead during the closing laps of the final stage, but a series of caution flags forced him to try to keep his car out front on restart after restart. When the race headed to overtime after yet another multicar incident with three laps to go, the RFK Racing driver needed to shoot to the lead one final time. Instead, he lost it when Shane Van Gisbergen gave his No. 17 Ford a shove after the green flag waved before the New Zealand native pulled his No. 16 Chevrolet alongside Buescher and Carson Hocevar, who had restarted first and second. Van Gisbergen, a three-time Australian Supercars champion who will make the jump to full-time NASCAR Cup Series driver in 2025, pulled away from Buescher and seemed to be heading for victory.

But Buescher wasn’t done. He gathered himself and chased down Van Gisbergen before finally getting to his rear bumper on the white-flag lap. After getting bumped on the restart, Buescher gave Van Gisbergen a bump of his own in the carousel, pulled alongside and retook the lead, then held over the final few turns to earn his first road course win in 36 starts.

“I thought we lost it there on that last one and to stay right there with him – that was the spot he was better than us and he missed it, so I tried a crossover. He went to cut and just hard racing there,” Buescher said. “It’s just such an awesome finish. To be that good for so much at the end of the race, all race, to get a win is good. We came here to be a spoiler and we’re gonna do that.”

The victory was Buescher’s first of the season and the sixth of his Cup Series career and prevented a playoff driver from clinching an automatic

berth into the second round.

The top five finishers in Sunday’s race were all non-playoff drivers, with Van Gisbergen finishing second, Hocevar third, pole winner Ross Chastain fourth and Zane Smith fifth.

“I gave him a little bump to get the spot, and I knew it was going to come back,” Van Gisbergen said. “So, I was just pushing the entries and trying to get away and just made an error. ... (Our Camaro) was really good, fastest car all day, and it just didn’t work out.”

Chase Briscoe led playoff drivers, finishing sixth, while Austin Cindric was the only other playoff driver to finish in the Top 10, coming home 10th in a race where most of the 16 playoff drivers were involved in at least once incident. Michael McDowell finished seventh, Corey LaJoie eighth and Ryan Preece ninth.

Watkins Glen proves rough for most NASCAR playoff drivers

The race was a turbulent one for most of the 16 drivers in the playoff field. Only two – Chase Briscoe and Austin Cindric – finished in the Top 10, while another – reigning series champion Ryan Blaney – finished last after a first-lap crash that ended his day.

William Byron, who won last year’s race at Watkins Glen, finished 34th out of 38 drivers after a late crash nearly tailed his Chevrolet, while Denny Hamlin had his second consecutive misfire in a playoff race and now sits below the 12-driver cutline along with former series champions Marin Truex Jr. (2017) and Brad Keselowski (2012).

The bottom four drivers in the standings after Saturday’s race at Bristol Motor Speedway will be eliminated from championship contention.

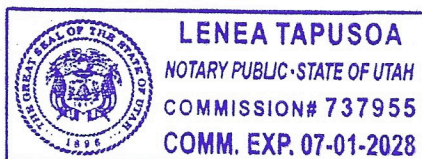
