ID 24-489 Right-of-Way Transition Plan

The Right-of-Way Transition Plan consists of three areas:

- 1. Curb Ramps
- 2. Sidewalks
- 3. Accessible Pedestrian Signals (APS)

The goal of the Right-of-Way Transition Plan is to ensure that the City maintains accessible paths of travel in the ROW for people with disabilities. The Transition Plan describes existing policies and programs to enhance accessibility in the ROW.

ADA Coordinator Joe Hinojosa briefly reviewed each of the 3 areas of the transition plan. The City of Fresno has 17% of its city with updated APS installed. There was much discussion regarding accessible pedestrian signals. Joe Hinojosa responded to questions from the commission. He will provide the commission with a list of APS locations. He will also email the Transition Plan to the commission for their comments and input.
