A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE ACCEPTANCE OF GRANT FUNDING FROM THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT ECONOMIC DEVELOPMENT INITIATIVE, COMMUNITY PROJECT FUNDING IN THE AMOUNT OF \$1,000,000 FOR FRESNO'S TINY HOMES HOUSING SOLUTIONS PROJECT

WHEREAS, the congressionally-directed spending under the Economic Development Initiative, Community Project Funding (CPF) authorized by the Consolidated Appropriations Act, 2023 (Public Law 117-328) provides investment in a wide variety of projects including housing; and

WHEREAS, the City submitted congressionally-directed applications for an initiative titled Fresno's Tiny Homes Housing Solutions Project to construct tiny homes to provide an affordable permanent housing solution to help homeless individuals transition out of shelters; and

WHEREAS, the City's application was selected to receive \$1,000,000 in CPF funds pursuant to the Explanatory Statement for Division L of the Consolidated Appropriations Act, 2023; and

WHEREAS, the U.S. Department of Housing and Urban Development's Office of Community Planning and Development, Congressional Grants Division is responsible for the administration of congressionally-directed spending under the CPF program; and

WHEREAS, the City must enter into a CPF Grant Agreement with HUD to participate in the program and receive the funds.
