A RESOLUTION OF THE COUNCIL ESTABLISHING THE  
CENTRAL SOUTHEAST AREA SPECIFIC PLAN  
STEERING COMMITTEE

WHEREAS, the Council desires to prepare a specific planning document for future Council consideration for the Central Southeast Area in order to provide for orderly development and in order to set forth a long term planning vision and guidance for development in the proposed plan area over the next 20 to 30 years; and

WHEREAS, involvement of the community in creating a specific planning document provides significant benefits to the City and to the community; and

WHEREAS, creation of a steering committee facilitates participation of community members in preparing the specific plan.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Central Southeast Area Specific Plan Steering Committee is hereby established.

2. The Purpose of the Central Southeast Area Specific Plan Steering Committee is to facilitate community involvement in preparation of the Central Southeast Area Specific Plan.

3. The Central Southeast Area Specific Plan Steering Committee shall continue to exist until the mission of the body is completed. The Central Southeast Area Specific

- 5. The term of office shall be at the pleasure of the appointing authority.

- 7. The Staff Representative shall be Drew B. Wilson.
