The Fresno Chamber of Commerce respectfully writes in support of the Enterprise Accountability & Oversight Act, which would ensure fiscal responsibility and transparency when the City uses rate-payer money to fund major projects.

The Chamber is in favor of this act for the following reasons:

- It promotes proper management for projects to be completed on time and on budget
- It ensures rate-payer money is used only for the project identified and nothing else, and any money leftover be available to reduce future rates
- It establishes an oversight board to review projects over \$20 million

The Fresno Chamber also supports the City's plan to raise water rates to fund improved water infrastructure. The Enterprise Accountability & Oversight Act perfectly compliments the proposed water plan and protects the best interests of residents and rate payers.
