A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA ADOPTING A FIVE-YEAR CAMP FRESNO FEE PLAN

WHEREAS, the City of Fresno obtained thirty-four acres on the banks of Dinkey

Creek near Shaver Lake in 1926 under a Special Use Permit issued by the United

States Forest Service; and

WHEREAS, the City of Fresno constructed Camp Fresno to provide low cost

camping facilities for groups and individual families; and

WHEREAS, four additional acres were added to the camp in 1956 for the

construction of Camp Fresno Jr.; and

WHEREAS, the City charges fees for rental of the above-noted camp sites and

facilities therein, which include fees (Fees) necessary for the continued operations and

maintenance of camp facilities including capital projects; and

WHEREAS, the Fresno Parks, After School, Recreation and Community

Services Department (PARCS) recommends annually adjusting the Fees in accordance

with the twelve month percentage change in the U.S. Bureau of Labor Statistics

Consumer Price Index (CPI) (Urban Wage Earners and Clerical Workers for the San

Francisco-Oakland-San Jose area), for the most current month that data is available;

and

WHEREAS, Fee increases are intended to generate funds which will help pay for

ongoing maintenance of facilities and replacement of aging infrastructure so that

services may continue to be offered; and
