WHEREAS, on August 18, 2022, the Council of the City of Fresno heard staff presentations and public comment regarding the West Area Neighborhoods Specific Plan and Final EIR SCH No. 2019069117; and

WHEREAS, on August 18, 2022, the Council of the City of Fresno completed deliberations and took action on the West Area Neighborhoods Specific Plan and Final EIR SCH No. 2019069117; and

WHEREAS, changes to the West Area Neighborhoods Specific Plan require clerical updates to the text, policies, tables, maps, and figures contained in the Fresno General Plan.
