A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO ADOPTING THE 538<sup>th</sup> AMENDMENT TO THE MASTER FEE SCHEDULE RESOLUTION NO. 80-420 TO ADD A PROMOTIONAL FARE RATE AND INCLUDE LANGUAGE ALLOWING FOR THE TRANSPORTATION DIRECTOR TO REDUCE FARES FOR PILOT PROGRAMS NOT TO EXCEED ONE YEAR IN DURATION

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF FRESNO:

THAT the Master Fee Schedule Resolution No. 80-420 be and is hereby amended to add a promotional fare rate and include language allowing for the Transportation Director to reduce fares for pilot programs not to exceed one year in duration. The revised pages of the Master Fee Schedule are attached as Exhibit "A" and are hereby incorporated by reference and made a part of this Resolution.

THAT the fees added by this RESOLUTION shall become effective on October 2, 2017.

Waiver: The Transit Director is authorized to waive or reduce fares for special or promotional events up to three days per fiscal year- or for pilot projects not to exceed one year in duration.
