A RESOLUTION OF THE COUNCIL OF THE CITY OF  
FRESNO, CALIFORNIA, TO REPEAL THE ZONING  
DESIGNATION TRANSLATION TABLE

WHEREAS, on November 19, 2015 the City Council adopted Resolution No. 2015-208, "A Resolution of the Council of the City of Fresno, California, to Implement the Zoning Designation Translation Table" in order to allow for continued development in the City of Fresno following adoption of the Citywide Development Code, but prior to rezoning parcels within the City; and

WHEREAS, on February 25, 2016, the City Council adopted Resolution No. 2016-28 to amend the Zoning Designation Translation Table such that it only applied to the Downtown Planning Area in order to allow for continued development prior to rezoning parcels within the Downtown Planning Area; and

WHEREAS, on November \_\_\_\_, 2016, the City Council approved Text Amendment TA-16-002, which amended the Fresno Municipal Code to include new base and overlay zone districts for the Downtown Planning Area; and

WHEREAS, on October 20, 2016, the City Council approved Ordinance Bill No. \_\_\_\_\_ which applied new base and overlay zone districts to parcels within the Downtown Planning Area; and

WHEREAS, application of the new base and overlay zoning districts in the Downtown Planning renders the Zoning Designation Translation Table unnecessary.
