A RESOLUTION OF THE COUNCIL OF THE CITY OF  
FRESNO, CALIFORNIA, ADOPTING THE ARTISTIC  
CROSSWALK POLICY

WHEREAS, artistic crosswalks are a way to represent a neighborhood and the Fresno community; and

WHEREAS, artistic crosswalks can be used to showcase a community's unique culture and history or liven up an intersection with artistic and colorful designs; and

WHEREAS, it is necessary to evaluate artistic crosswalk applications in light of the primary purpose of streets is safe travel for pedestrians, vehicles and other forms of transportation; and

WHEREAS, the City will choose the types of crosswalk art that will be displayed to promote the interests of the City pursuant to the regulations and procedures set forth in the Artistic Crosswalk Policy; and

WHEREAS, this Resolution and the Artistic Crosswalk Policy is not intended to create any public forum, but at most shall constitute government speech and be available solely as outlined in the Artistic Crosswalk Policy; and

WHEREAS, the Artistic Crosswalk Policy outlines the procedures and processes for artistic crosswalks and defines eligibility, locations, design standards, material and paint type, application and permitting, waiver of artist's rights and maintenance.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Council adopts Artistic Crosswalk Policy attached as Exhibit A and fully incorporated herein.
