A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, SUPPORTING THE SUCCESS OF THE TOWER DISTRICT FARMER'S MARKET ON THURSDAY EVENINGS

WHEREAS, the City intends to allow a local nonprofit entity to host a farmer's market on Olive Avenue in the Tower District on Thursdays beginning in April 2023; and

WHEREAS, temporary street closures are common in order to accommodate farmer's markets and ensure the safety of vendors and customers; and

WHEREAS, the City intends to temporarily close Olive Avenue between Wishon Avenue and Echo Avenue to through traffic on each Thursday evening beginning at 2:00 p.m. and ending at 10:00 p.m. in order to vacate street traffic to accommodate a weekly farmer's market; and

WHEREAS, it is Council's policy to encourage events such as the farmer's market that bring together the community in an outdoor setting, provide opportunities for residents to purchase fresh food, and provide a venue for local businesses to sell their goods; and

WHEREAS, the farmer's market will provide fresh produce, prepared foods, live music, children's areas, and other similar offerings which will attract the community and stimulate the local economy; and

WHEREAS, the logistics of implementing a successful farmer's market include but not limited to the rerouting bus transit and temporarily closing the two corresponding bus stops while the farmer's market is operating will allow residents to attend, participate in, and purchase food at the farmer's market without concerns about pedestrian safety.
