The project has a comparatively small construction allocation, and this is reflected in the unit pricing since economy of scale does not factor into this project. The lack of bids from prospective bidders is likely due to the small construction value of the project, despite there being significant interest in the project during advertisement as evidenced by the distribution of specifications to twenty-eight (28) perspective bidders. This is the second unsuccessful attempt to competitively bid the project.

<u>BACKGROUND OF PROJECT</u>: The project will provide improved pedestrian safety at three existing school crossings. In addition to the installation of RRFBs, existing pedestrian ramps, crosswalk and lane striping, signage, curb and gutter, sidewalk and lighting will be reconstructed.

The project originally advertised on 5/1/24 and received zero (0) qualified bids. It was rebid on 7/19/24 and received one (1) qualified bid.
