A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE DEPARTMENT OF TRANSPORTATION TO EXECUTE AND FILE ALL NECESSARY DOCUMENTS ON BEHALF OF THE CITY OF FRESNO PERTAINING TO THE CALIFORNIA AIR RESOURCES BOARD (CARB) INNOVATIVE CLEAN TRANSIT (ICT) REGULATION AND EXECUTION OF RELATED AGENT FORMS

WHEREAS, the State of California continues to move the needle in adopting ambitious climate, energy and transportation goals, to improve air quality and reduce health impacts from emissions, and to develop a strong clean energy economy that creates sustainable jobs; and

WHEREAS, the California Air Resources Board (CARB) adopted the Innovative Clean Transit (ICT) regulation on December 14, 2018; and

WHEREAS, the ICT regulation requires transit agencies in the State of California to begin to purchase zero-emission buses (ZEBs) as soon as 2023, with the goal of transitioning all transit buses in California to zero-emission technology by 2040; and

WHEREAS, each transit agency must submit a rollout plan under the regulation demonstrating how it plans to purchase zero emission buses, build out necessary infrastructure, and train the required workforces; and

WHEREAS, CARB requires the submittal of the rollout plans by July 1, 2020; and NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:
