BILL – (For introduction) – Adding Section 3-125 to Chapter 3 of the Fresno Municipal Code relating to Stipends for City Council Interns (All Council Districts)

ORDINANCE NO. _____

AN ORDINANCE OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, ADDING SECTION 3-125 TO CHAPTER 3 OF THE FRESNO MUNICIPAL CODE RELATING TO STIPENDS FOR CITY COUNCIL INTERNSHIPS.

THE COUNCIL OF THE CITY OF FRESNO DOES ORDAIN AS FOLLOWS:

SECTION 1. Section 3-125 is added to Article 1 of the Fresno Municipal Code to read:

SECTION 3-125. – STIPENDS FOR CITY COUNCIL INTERNSHIPS.

Individuals who volunteer as interns within an office of a City Councilmember may be issued a maximum stipend of \$500 per month for the duration of the internship to defray out of pocket and incidental expenses related to the internship. Stipends shall be allocated from the discretionary budget of the Council District for which the intern volunteers.

SECTION 2. This Ordinance shall become effective and in full force and effect at 12:01 a.m. on the thirty-first day after its final passage.
