

FIRST AMENDMENT TO AGREEMENT

THIS FIRST AMENDMENT TO AGREEMENT (Amendment) made and entered into effect the 11th day of August 2022, between the City of Fresno, a California municipal corporation (City), and Make Green Go LLC., a California limited liability company (Consultant).

RECITALS

WHEREAS, the City and the Consultant entered into an agreement on August 1, 2021, (Agreement) to provide professional cannabis business development technical assistance services for the Office of Cannabis Oversight Equity Assistance Program (the Project); and

WHEREAS, the City and the Consultant desire to extend the term of the Agreement to October 31, 2022 to complete the Project; and

WHEREAS, with entry into this Amendment, the Consultant agrees it has no claim, demand, or dispute against the City.

AGREEMENT

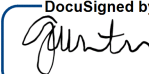
NOW, THEREFORE, the parties agree that the Agreement be amended as follows:

3. Except as otherwise provided herein, the Agreement remains in full force and effect.

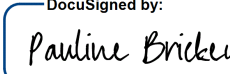

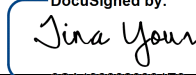

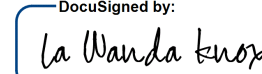
