

AGREEMENT TO TRANSFER OWNERSHIP OF WASTEWATER ASSETS AND WASTEWATER SERVICE

This Agreement is made and entered into effective _____, 2024, (Effective Date) by and between the CITY OF FRESNO, a California municipal corporation (City), and PINEDALE PUBLIC UTILITY DISTRICT (District), an independent special district organized and operating under the Public Utility District Act, California Public Utilities Code section 15501, et. seq. (collectively, the Parties).

RECITALS

A. District was formed in 1950 under the Municipal District Act of 1921 for the specific purpose of providing wastewater collection and treatment to unincorporated subdivisions west of the unincorporated Pinedale community.

B. District provides sewer service to the area west of Pinedale, including territory both within the City and in adjacent unincorporated areas, within and outside of the District's service area, and outside its sphere of influence.

C. City was designated by the County of Fresno (County) as the Chief Sewering Agent in 1966. The City owns and operates a publicly owned treatment works (POTW) used for transportation and treatment of wastewater and sewage. Between 1974 and 1977, the City expanded the POTW by the construction of the West Fresno-Herndon Interceptor and enlarged its regional wastewater treatment facilities.

D. In July 2022, the District's Board of Directors (Board) found that the District, although it has adequate financial support to implement the mission of the District, has become redundant to services provided by the City and County and other service providers. As such, the Board adopted "RESOLUTION NO. 2022-10, A Resolution Authorizing District Dissolution and Disposition of Assets and Application to the Local Agency Formation Commission to Take Proceedings for Dissolution of the District."

E. Following adoption of that resolution, the District and the City engaged in further discussions and determined that rather than dissolving the District, the best course of action is to divest the District of the power to provide wastewater collection services and transfer all wastewater collection facilities, billing responsibilities, customers, and maintenance obligations to the City. As such, the Board adopted "RESOLUTION NO. 2023-04, A Resolution Authorizing the Pinedale Public Utility District to Transfer Wastewater Collection Services to the City of Fresno."

F. City and District now desire to effectuate the transfer of ownership of the District's Wastewater Assets, as defined below, from the District to the City and to transfer all obligations related to providing wastewater collection services.

AGREEMENT

NOW, THEREFORE, in consideration of the mutual covenants set forth herein and for other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the parties hereto, agree as follows:

1. Recitals. The Recitals set forth above are incorporated herein by reference.
2. Definitions. The following terms are defined as follows for purposes of this agreement.

2.1. Act. Act means the Cortese-Knox Local Government Reorganization Act of 2000.

2.2. Wastewater Assets. Assets means the intangible, tangible, or real property held by the District that are related to wastewater and sewage infrastructure located within the boundaries depicted in **Exhibit 2.1**. This includes funds to be transferred to the City for the repair and ongoing maintenance of the physical wastewater assets. The Wastewater Assets are as identified in **Exhibit 1**.

It is known by the parties that the District does not maintain an inventory of goods as it does not sell products.

2.3. Fresno LAFCO. Fresno LAFCO means the Local Agency Formation Commission, which is the state mandated independent local agency established to oversee the boundaries of cities and special districts in Fresno County.

2.4. Service Area. Service Area means the geographic area within the District where the District provides authorized services. The District's current service area is set forth in **Exhibit 2.1**. Effective July 1, 2024, the District's Service Area, for all services other than wastewater, will be as depicted in **Exhibits 2.2** and **2.3**.

2.5. Successor. Successor means the city, county, or district, or local agency that succeeds to the wastewater services currently provided by the District.

3. Transfer of Ownership. The Parties acknowledge that the District currently provides wastewater collection services to properties within the boundaries of the District and to some customers located outside the district but within the District's sphere of influence (as represented in **Exhibit 2.1**), collects the monthly sewer service charge, and maintains its wastewater and sewage collection facilities.

- a. The Parties agree that effective July 1, 2024, City will assume ownership and maintenance responsibilities for all of the District's Wastewater Assets, responsibility for the District's wastewater customers, and responsibility for billing and collecting the monthly sewer service charge for all transferred properties receiving sewer service within the District. The specific Assessor Parcel Numbers (APN) receiving sewer service and from which the City will bill and collect the sewer service charge are identified in **Exhibit 3**.

- b. In addition to transferring ownership of the physical infrastructure within the boundaries depicted in **Exhibit 2.1**, District will also transfer \$3.2 million to the City for the ongoing repair and maintenance of the wastewater assets as shown in **Exhibit 1**. This transfer must be complete within 30 days of the Effective Date of this Agreement. The City will establish a separate account for these funds and will provide District with information necessary to effectuate the transfer.
 - c. The Parties acknowledge that the monthly sewer service charges for commercial properties within the District are billed in arrears. The first billing performed by City will include service charges incurred in the two months preceding the billing date. District agrees that as of July 1, 2024, it will have no right to bill or collect the monthly sewer service charge from any of the APNs identified in **Exhibit 3**.
 - d. The Parties agree that no later than 30 days before the transfer, City will provide the affected customers with notice of the change in billing for wastewater services.
 - e. The Parties acknowledge that currently, the District also provides street light maintenance, median island landscape maintenance, and street sweeping within its Service Area. After July 1, 2024, the District will continue to provide street sweeping services, streetlight maintenance, and median island landscape maintenance in the area depicted in **Exhibits 2.2** and **2.3**. This Agreement does not impact or relate to these remaining services. The City will not assume any responsibility for street sweeping, streetlight maintenance, and median island landscape maintenance within the area depicted in **Exhibits 2.2** and **2.3** or within any other area.
 - f. Following the transfer addressed in this Section, the District will provide only street sweeping, streetlight maintenance, and median island landscape maintenance within the boundaries depicted in **Exhibits 2.2** and **2.3**.
 - g. The City shall assume the corporate powers of the District with respect to the wastewater services currently provided by the District as though it was the District's Successor pursuant to Gov. Code § 56886 for those services, except that the District has ensured that all District debts related to wastewater services were paid prior to the Effective Date of this agreement. In executing this agreement, the City does not assume any indebtedness related to the Wastewater Assets.
 - h. Any delay caused by any third-party to the completion of the obligations in this Section 3 shall not be considered attributable to the City or District and any such delay or delays shall not be considered a breach of the obligations required of this section.
 - i. The City is not required by this Agreement to continue or modify the employment of any District employee, nor honor any service, seniority, or retirement rights of a District employee retained by the City, nor provide any other employee benefits and rights held by a District employee who may be retained by the City.
4. Revision to District Boundaries and Sphere of Influence.
- a. Within ninety (90) days of the Effective Date of this Agreement, the District shall complete a reorganization process with Fresno LAFCo, including completion of a

Municipal Service Review. Any Application for Change of Organization/ Reorganization filed with Fresno LAFCO shall include the following:

- i. A proposal that the District's sphere of influence, service area, and boundaries be revised to be coextensive with and limited to the area reflected in **Exhibit 2.2** and **Exhibit 2.3**; and
 - ii. A copy of this Agreement with a request that the District be formally divested of the power to provide wastewater collection services and a request that its authorized services be limited to street sweeping, streetlight maintenance, and median island landscape maintenance.
- b. If District fails to file an Application with Fresno LAFCo, District agrees that it will not oppose, protest, or otherwise object to any proceedings to revise its SOI and authorized services consistent with this agreement.

5. Indemnification. City shall indemnify, hold harmless and defend District and each of its officers, officials, employees, agents and volunteers from any and all loss, liability, fines, penalties, forfeitures, costs and damages (whether in contract, tort or strict liability, including but not limited to personal injury, death at any time and property damage) incurred by District, City or any other person, and from any and all claims, demands and actions in law or equity (including attorney's fees and litigation expense), arising or alleged to have arisen directly or indirectly from the negligent or intentional acts or omissions, or willful misconduct of City or any of its officers, officials, employees, agents, or volunteers in the performance of this Agreement; provided nothing herein shall constitute a waiver by City of governmental immunities including California Government Code section 810 et seq.

District shall indemnify, hold harmless and defend City and each of its officers, officials, employees, agents, and volunteers from any and all loss, liability, fines, penalties, forfeitures, costs and damages (whether in contract, tort or strict liability, including but not limited to personal injury, death at any time and property damage) incurred by the City, District or any other person, and from any and all claims, demands and actions in law or equity (including attorney's fees and litigation expenses), arising or alleged to have arisen directly or indirectly from the negligent or intentional acts or omissions, or willful misconduct of District or any of its officers, officials, employees, agents, or volunteers in the performance of this Agreement; provided nothing herein shall constitute a waiver by District of governmental immunities including California Government Code section 810 et seq.

In the event of concurrent negligence on the part of City or any of its officers, officials, employees, agents, or volunteers, and District or any of its officers, officials, employees, agents, or volunteers, the liability for any and all such claims, demands and actions in law or equity for such losses, fines, penalties, forfeitures, costs and damages shall be apportioned under the State of California's theory of comparative negligence as presently established or as may be modified hereafter.

This section shall survive termination or expiration of this Agreement.

6. Governing Law and Venue. This Agreement shall be governed by, and construed and enforced in accordance with, the laws of the State of California, excluding, however, any conflict of laws rule which would apply the law of another jurisdiction. Venue

for purposes of the filing of any action regarding the enforcement or interpretation of this Agreement and any rights and duties hereunder shall be Fresno County, California.

7. Headings. The section headings in this Agreement are for convenience and reference only and shall not be construed or held in any way to explain, modify, or add to the interpretation or meaning of the provisions of this Agreement.

8. Severability. The provisions of this Agreement are severable. The invalidity or unenforceability of any one provision in this Agreement shall not affect the other provisions.

9. Interpretation. The parties acknowledge that this Agreement in its final form is the result of the combined efforts of the parties and that, should any provisions of this Agreement be found to be ambiguous in any way, such ambiguity shall not be resolved by construing this Agreement in favor of or against either party, but rather by construing the terms in accordance with their generally accepted meaning.

10. Attorney's Fees. If either party is required to commence any proceeding or legal action to enforce or interpret any term, covenant or condition of this Agreement, the prevailing party in such proceedings or action shall be entitled to recover from the other party its reasonable attorney's fees and legal expenses.

11. Exhibits. Each exhibit and attachment referenced in this Agreement is, by reference, incorporated into and made a part of this Agreement.

12. Precedence of Documents. In the event of any conflict between the body of this Agreement and any exhibit or attachment hereto, the terms and conditions of the body of this Agreement shall control and take precedence over the terms and conditions expressed within any exhibit or attachment hereto which purport to modify the allocation of risk between the parties, provided for within the body of this Agreement, shall be null and void.

13. Cumulative Remedies. No remedy or election hereunder shall be deemed exclusive but shall, wherever possible, be cumulative with all other remedies at law or in equity.

14. No Third-Party Benefits. The rights, interests, duties, and obligations defined within this Agreement are intended for the specific parties hereto as identified in the preamble of this Agreement. Notwithstanding anything stated to the contrary in this Agreement, it is not intended that any rights or interests in this Agreement benefit or flow to the interest of any third parties.

15. Extent of Agreement. Each party acknowledges that they have read and fully understand the contents of this Agreement. This Agreement represents the entire and integrated agreement between the parties with respect to the subject matter hereof and supersedes all prior negotiations, representations or agreements, either written or oral. This Agreement may be modified only by written agreement duly authorized and executed by both City and District.

16. Notice. Any notice required or intended to be given to either party under the terms of this Agreement shall be in writing and shall be deemed to be duly given if delivered personally, transmitted by facsimile followed by telephone confirmation of receipt, or sent

by United States registered or certified mail, with postage prepaid, return receipt requested, addressed to the party to which notice is to be given at the party's address set forth on the signature page of this Agreement or at such other address as the parties may from time to time designate by written notice. Notice served by United States mail in the manner above described shall be deemed sufficiently served or given at the time of the mailing thereof.

17. Binding. Subject to Section 13, above, once this Agreement is signed by all parties, it shall be binding upon, and shall inure to the benefit of, all parties, and each parties' respective heirs, successors, assigns, transferees, agents, servants, employees, and representatives.

18. Compliance with Law. The Parties shall at all times comply with all applicable laws of the United States, the State of California, City, and District, and with all applicable regulations promulgated by federal, state, regional, or local administrative and regulatory agencies, now in force and as they may be enacted, issued, or amended during the term of this Agreement.

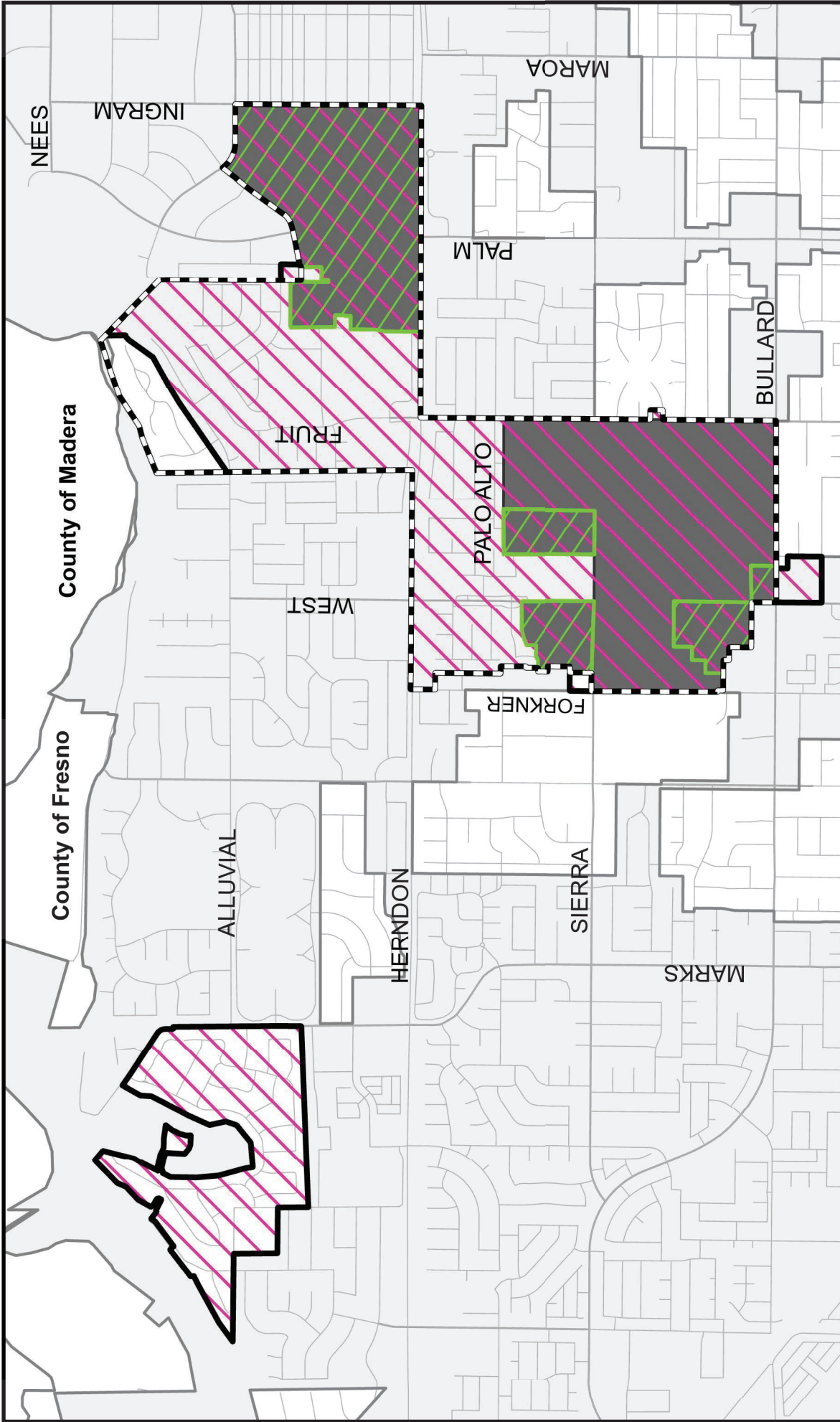

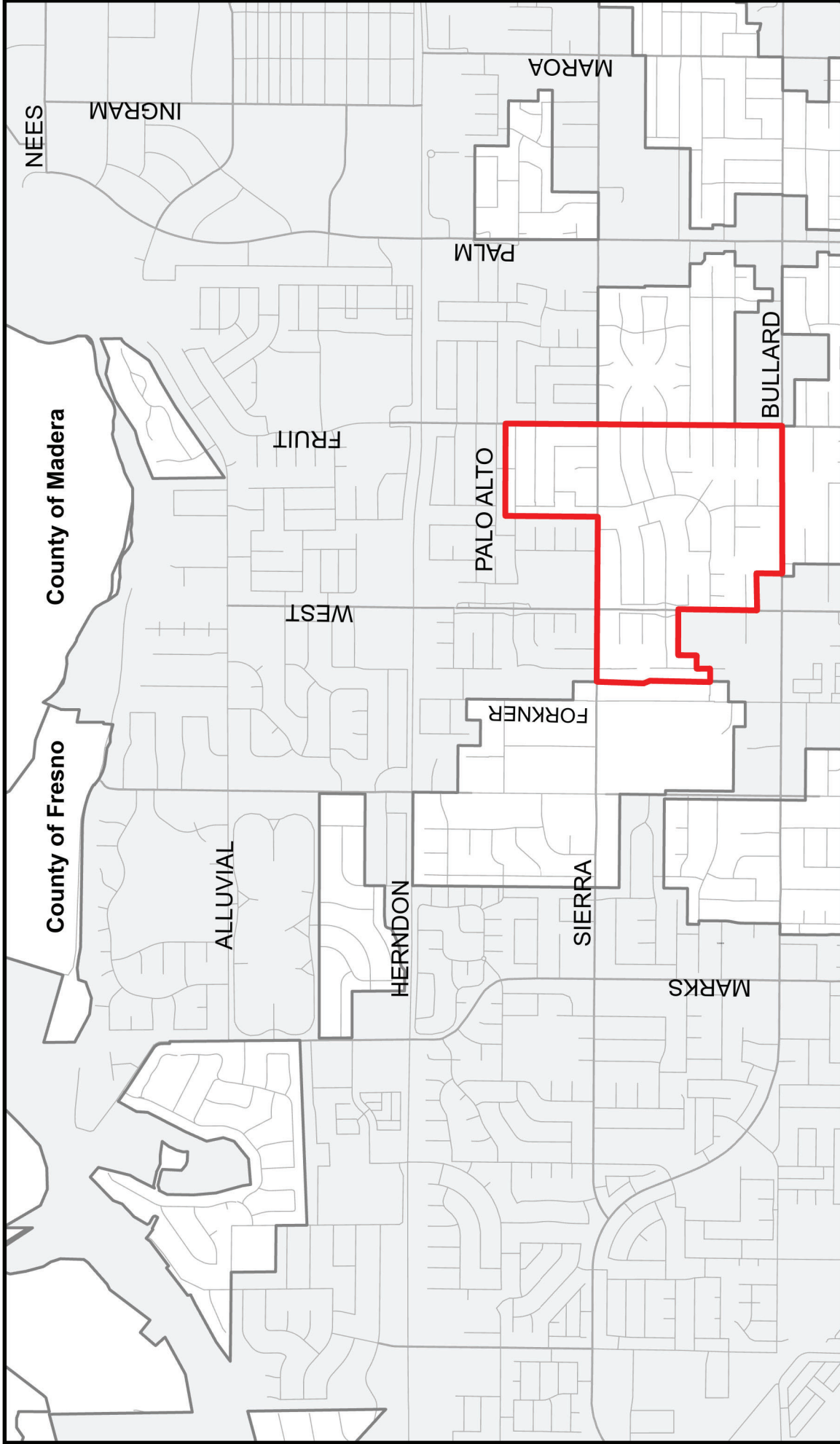
Exhibit 2.1 - Service Area Map (Pre-Transfer)

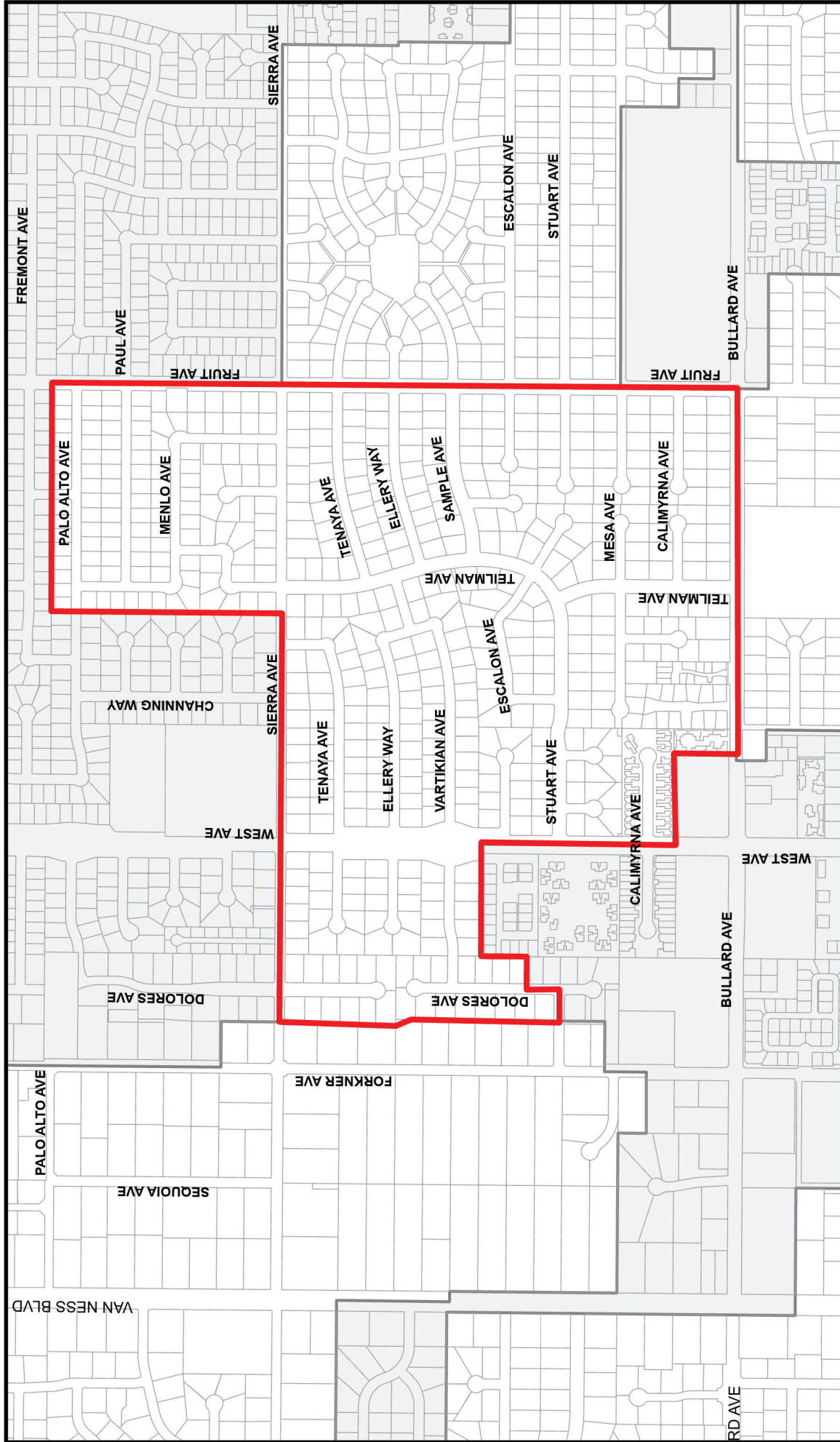


 District Service Area/Boundaries/Sphere of Influence Post-Transfer
