PROJECT DESCRIPTION: The City of Fresno, Public Works Department, is proposing to, (1) conform grind existing pavement, (2) place 0.2' thick AC overlay, (3) upgrade deficient curb ramps to current ADA standards, (4) relocation of a water valve and sewer manhole lids, and (5) replace damaged loop detectors, signage, and striping.

This project is exempt under Sections 15301/Class 1 and 15302/Class 2 of the State of California CEQA Guidelines. None of the exceptions to Categorical Exemptions set forth in the CEQA Guidelines, Section 15300.2 apply to this project.

EXPLANATION: Section 15301/Class 1 consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The types of "existing facilities" itemized below are not intended to be all-inclusive of the types of projects which might fall within Class 1. The key consideration is whether the project involves negligible or no expansion of an existing use. Examples include but are not limited to existing highways and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities (this includes road grading for the purpose of public safety).

Section 15302/Class 2 consists of replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced, including but not limited to: water main, sewage, electrical, gas, and other utility extensions, including street improvements, of reasonable length to serve such construction.

The proposed project consists of the reconstruction of deficient curb ramps. The subject properties are located within a developed urban area, designated as commercial community, residential single family and residential multi-family, and substantially surrounded by urban uses. The site has no value as habitat for endangered, rare or threatened species. No adverse environmental impacts would occur as a result of the proposed project. The site can be adequately served by sewer and water facilities.

Based on staff analysis, it was determined that no adverse environmental impacts would occur as a result of the proposed project and none of the exceptions to Categorical Exemptions set forth in the CEQA Guidelines Section 15300.2 apply to this project. Therefore, a categorical exemption, as noted above, has been prepared for the project.
