A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE CITY MANAGER OR DESIGNEE TO APPLY FOR AND ACCEPT UP TO \$500,000 FROM FRESNO UNIFIED SCHOOL DISTRICT TO FUND BLUE SPACE AQUATICS PROGRAMMING AT UP TO SEVEN HIGH SCHOOLS AND UP TO FOUR CITY OF FRESNO POOL LOCATIONS DURING SUMMER 2026

WHEREAS, Fresno Unified School District (FUSD) and the Parks, After School, Recreation, and Community Services (PARCS) Department have worked together for many years to provide programming to the Fresno community including collaboration through the Blue Space Program; and

WHEREAS, partnering with FUSD will allow the City to serve more community members by providing opportunities to the community to learn the importance of water safety, become efficient swimmers, and stay cool from the summer heat; and

WHEREAS, FUSD periodically releases a call for proposals to fund extended learning and enrichment programming in the community; and

WHEREAS, the City is seeking authority to apply for and accept funding to provide aquatics programming to the community in Summer 2026; and

WHEREAS, the City, if successful, will enter into an agreement with FUSD for the implementation of Blue Space aquatics programming.

1. Council authorizes the City Manager or designee to submit a proposal to FUSD requesting reimbursement for up to \$500,000 for providing aquatics programming in Summer 2026.

Council authorizes City Manager or designee to accept funding, conduct negotiations, execute, submit, and sign all documents including but not limited to applications, agreements, contracts, amendments, payment requests, and other documents which may be necessary for acceptance of funding and implementation of FUSD-funded programming.
