**THIRD AMENDMENT TO AGREEMENT**

THIS THIRD AMENDMENT TO AGREEMENT ("Amendment") made and entered into as of this 1<sup>st</sup> day of July 2018, amends the Agreement heretofore entered into between the CITY OF FRESNO, a municipal corporation ("CITY"), and AECOM Technical Services, a California corporation ("CONSULTANT").

**RECITALS**

WHEREAS, CITY and CONSULTANT entered into an Agreement, dated July 31<sup>st</sup>, 2014, for services related to the preparation of the High Speed Rail Station Area Master Plan (Agreement"); and

WHEREAS, CITY and CONSULTANT now desire to modify the Agreement to extend the period for performance to December 31, 2018.

**AGREEMENT**

NOW, THEREFORE, in consideration of the above recitals, which recitals are contractual in nature, the mutual promises herein contained, and for other good and valuable consideration hereby acknowledge, the parties agree that the aforesaid Agreement be amended as follows:

1. Section 2 of the Agreement is amended such that the Term of the Agreement shall continue in full force and effect until December 31, 2018.

2. Except as otherwise provided herein, the Agreement entered into by CITY and CONSULTANT, effective July 31<sup>st</sup>, 2014, remains in full force and effect.

3. In the event of any conflict between the body of this Amendment and the Agreement, the terms and conditions of the body of this Amendment shall control and take precedence over the terms and conditions expressed within the Agreement. Furthermore, any terms or conditions contained within the Agreement which purport to modify the allocation of risk between the parties, provided for within the body of this Amendment, shall be null and void.




