WHEREAS, on July 15, 2024, the City released a public draft of the Parks Master Plan technical amendment for a 53-day public comment period; and,

WHEREAS, on August 8, 2024, the Council District 1 Project Review Committee was scheduled to review the Parks Master Plan technical amendment but did not reach a quorum; and,

WHEREAS, on August 27, 2024, the Council District 3 Project Review Committee reviewed the Parks Master Plan technical amendment and provided comments included in the public comment matrix; and,

WHEREAS, on August 28, 2024, the Council District 5 Project Review Committee was scheduled to review the public comment draft of the Parks Master Plan technical amendment but did not reach a quorum; and,

WHEREAS, on September 30, 2024, an addendum to mitigated negative declaration for environmental assessment No. A-17-016 was prepared for the adoption of the Parks Master Plan technical amendment and found that the Parks Master Plan technical amendment does not change or affect the previous findings of the MND; and,

WHEREAS, on October 7, 2024, the Airport Land Use Commission reviewed the Parks Master Plan technical amendment and related Environmental Assessment Addendum and found them to be consistent with airport land use plans; and,

WHEREAS, on October 14, 2024, Parks, Art, and Recreation Commission recommends approval of the Parks Master Plan technical amendment;
