The Engineer's Estimate for this expenditure is \$3,422,893.00. The contract price is 3.87% below the Engineer's Estimate.

BACKGROUND OF PROJECT

Differential settlement at the surface of the landfill is an ongoing occurrence and is influenced by the decomposition of the waste, age of waste, degree of waste compaction and climatic conditions. The Project includes filling and regrading of the top vegetative layer of the side slopes to restore areas of settlement to its original design grade. Letdown structures that have eroded over time due to climatic conditions will be reconstructed to provide optimal conveyance of stormwater from the side slopes to the perimeter channels that directs collected stormwater to the existing detention basins.

The LFG pipeline that traverses the side slopes to collect land fill gas has clogging issues at depressed areas caused by differential settlement, due to the accumulation of condensate that impedes gas flow to the landfill treatment system. The Project will relocate the LFG pipeline upslope to a location where historically, have not undergone significant settlement, and will upgrade related equipment and appurtenances to ensure proper function of the LFG collection system
