2023 PROFESSIONAL ENVIRONMENTAL CONSULTANT EVALUATION

On November 27, 2023 a Request for Qualifications (RFQ) was advertised seeking Statements of Qualifications (SOQ) from Environmental Engineering and related firms to provide consulting services including, but not limited to, environmental site assessment, hazardous materials surveying, identification of hazardous substances and solid wastes, reports, technical studies, permits, testing, analysis, mitigation plan preparation and monitoring at Fresno Yosemite International Airport (FAT) and Fresno Chandler Executive Airport (FCH) on an individual project or on call basis over the next five (5) years. The Airports Department received three (3) SOQs by the 3:00 PM January 5, 2024 deadline. The SOQs were evaluated by Cristal de la Torre, Jarred Garza, Jon Bartel, and Richard Madrigal (committee) using the six criteria listed in Section C of the RFQ.

Per FAA guidance issued in Advisory Circular (AC) 150/5100-14E "Architectural, Engineering, and Planning Consultant Services for Airport Grant Projects", this recruitment is for projects that are reasonably expected to be executed within a five year period on an individual project or on-call agreement basis.

The following is a summary of the committee's evaluation of firms that submitted SOQs:

Summary of Firms

Airquest Environmental / Traci-Anne Boyle 6851 Southwest 45th St. Fort Lauderdale, FL 33314

This firm is out of town. Their core competency is environmental and industrial hygiene consulting services, with specific concentrations in hazardous materials, asbestos, lead paint, indoor air quality, radon, soil and groundwater investigations, and worker exposure evaluations. They have limited airport experience. Their main clients are military, federal departments, and Kaiser Permanente. The committee determined that this firm is not qualified to provide consultant services for the Airports Department.

BSK Associates / Sarah Stephenson 691 N. Laverne Ave., Suite #101 Fresno, CA 93727

This firm is local has a variety of experience. They have previously been the consultant on the Airports PFAS program. They have also provided similar services to commercial and general aviation airports throughout the central valley. They specialize in environmental consulting, engineering, construction observation, materials testing, special inspection, and analytical laboratory services. The committee determined that this firm is qualified to provide consultant services for the Airports Department.
