The above item was introduced to Council by Council President Olivier.

Council President Olivier spoke regarding his concerns on cannabis regulations and the need for a consultant. Council President Olivier removed the \$100,000 from the report and placed no value on the consultant and mentioned he agrees with Mayor Brand to add a steering committee issuing of the RFQ that would consist of the Mayor and up to three Councilmembers. The Committee would help the Administration choose the right person for the job and would help the Administration to set the parameters and the scope of work for the professional consultant. He also read into the record a memo from Chief Donis and Chief Dyer regarding the issues of fires and the total number of calls to Fresno Police Department regarding marijuana.

Mayor Brand spoke regarding his support on hiring a professional consultant to research the cost to enforce recreational and medical marijuana, how to monitor and regulate 6 plants, the impact of the black market, how many dispensaries, the impact on land decisions and so on. Mayor Brand believes he will not need more than \$50,000 to hire a consultant and requested that the City Manager create an RFQ on a consultant and allow the subcommittee to review the outcome of the RFQ and come back to Council within 60 to 90 days for both medical and recreational marijuana.

Councilmember Caprioglio asked Council President if there was a need to consider the item since it is within the jurisdiction of the Mayor and doesn't need authorization from the Council. Council President Olivier disagrees and would like to take action on the item.

Upon call, the following members of the public addressed Council: Ted Miller, Mary Ester Correa, Michael Green, Carol Lapeer, Sam Pete, Leslie Otta, Susan Gervais, Marcus Martinez, George Boyjian, Dennis Ebacure, Martha Kolstad, Melissa Farris, Kim Castro, Sister Freya, Jason Crouse and Robert Huggins spoke on this item.

Councilmember Baines III supports Council President and Mayor Brand in obtaining a professional consultant.

Councilmember Bredefeld will not support the item. Councilmember Bredefeld believes the Mayor's staff as well as District 6 staff have the ability to research and provide Council with the necessary information needed. Bredefeld also mentioned that the \$50,000 would most likely be coming from the General Fund.

Councilmember Brandau stated hiring a consultant now is premature and would like to wait until there is enough data to review and then at that time if a consultant is needed to hire one. He opposed the item.

Councilmember Caprioglio asked Council President Olivier if the person from League of Cities was a consultant. Councilmember also stated that he would like the information to be provided now verse waiting that year. Councilmember Caprioglio supports the item.

Council President Olivier motioned to approve item as amended by removing the \$100,000 dollar amount and to include a Council subcommittee to help our professional City staff to set the parameters for the RFQ. Councilmember Baines III seconded the motion.
