FAX Facility Fire Alarm is not in compliance with the City of Fresno Fire Department code requirements. The existing fire alarm, when triggered, sends the Fire Department a location at MSC buildings instead of the correct location at FAX. Also, the fire pull devices are not ADA compliant in the existing locations. FAX is adding additional strobes and pull stations in locations that previously had none in order to provide increased fire safety and coverage.

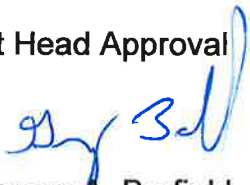
