A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, ESTABLISHING DESIGNATED PARADE ROUTES

WHEREAS, parades, marches, and other special events require substantial planning and preparation, both on the part of event-organizers, and on the part of the City staff; and

WHEREAS, pre-established routes with predetermined costs for crowd and traffic control would greatly help event-organizers to plan and budget for special events; and

WHEREAS, such pre-established routes would help to minimize the City staff time involved with processing applications for special event permits; and

WHEREAS, Fresno Municipal Code section 14-2414(f) authorizes the Council to establish designated parade routes for Expressive Activities, as defined in Fresno Municipal Code section 14-2403(f); and

WHEREAS, several rights-of-way within the City are either particularly suitable for hosting such special events, or have historically served as a venue for such events.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

- 1. Pursuant to section 14-2403(f) of the Fresno Municipal Code, the following Parade Routes are established in the City of Fresno. All routes are inclusive of staging areas:
 - a. "Downtown Loop"
 - i. Start at Inyo and Mono

- iii. Northwest on P Street to Fresno Street
- iv. Southwest on Fresno Street to M Street

- b. "Fulton Route"
 - i. Start at H Street and Inyo
 - ii. Northeast on Inyo to Fulton Street
 - iii. Northwest on Fulton Street to Calaveras
 - iv. Northeast on Calaveras, end at L Street
- c. "Olive/Hedges Loop"
 - i. Begin at Ferger and Olive
 - ii. East on Olive to Maroa
 - iii. North on Maroa to Hedges
 - iv. West on Hedges to Roosevelt
 - v. South on Roosevelt to Olive
 - vi. West on Olive, end at Ferger
- d. "O Street Route"
 - i. Begin at M Street and Inyo
 - ii. Northeast on Inyo to O Street
 - iii. Northwest on O Street, end at Tuolomne.
- e. "Olive Route"
 - i. Begin at Palm and Olive

- ii. East on Olive, end at Fulton Street.
- f. "City Hall Loop"
 - i. Begin at Fresno Street and R Street
 - ii. Southeast on R Street to Tulare
 - iii. Southwest on Tulare to P Street
 - iv. Northwest on P Street, end at Fresno Street.
- g. "Chinatown Route"
 - i. Road closures:
 - ii. E Street between Inyo and Mariposa
 - iii. Mariposa between E Street and F Street
 - iv. Tulare between E Street and F Street
 - v. F Street between Mariposa and Kern
 - vi. Kern between C Street and F Street
- h. "Mariposa Route"
- i. Road closure between Mariposa between Broadway and Fulton.
- 2. In accordance with subsection (g) of section 14-2403 of the Fresno Municipal Code, the City Manager is directed to specify the number of officers to be assigned to each route for crowd and traffic control. In addition, staff is directed to publish the following on the City's website: the aforementioned routes, the number of officers assigned to each route, and the fee schedule for police crowd and traffic control services.
