A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING AND DIRECTING THE SUBMISSION OF A GRANT APPLICATION TO THE STATE OF CALIFORNIA DEPARTMENT OF TOXIC SUBSTANCES CONTROL'S EQUITABLE COMMUNITY REVITALIZATION GRANT ROUND 2, AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO SIGN ALL REQUIRED APPLYING DOCUMENTS

WHEREAS, the State of California Department of Toxic Substances Control (DTSC) issued an Equitable Community Revitalization Grant (ECRG) Round 2 Guidelines soliciting applications on August 14, 2023, to implement the Cleanup in Vulnerable Communities Initiative under Senate Bill 158 (Chapter 73, Statutes of 2021) allocating \$500 million to DTSC for the cleanup and beneficial reuse of properties in historically vulnerable and disadvantaged communities; and

WHEREAS, approximately \$85 million is available for Round 2 of the ECRG application, which closes on October 9, 2023; and

WHEREAS, the City of Fresno (City) is an eligible entity to apply for up to \$10 million to facilitate the remediation of 1457 H Street (Site), to allow for a revitalizing reuse of the Site; and

WHEREAS, the City wishes to submit an application for an allocation of ECRG funding not to exceed \$10,000,000.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:
