RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION FOR \$10,540,582 FROM THE UNITED STATES DEPARTMENT OF TRANSPORTATION'S BETTER UTILIZING INVESTMENTS TO LEVERAGE DEVELOPMENT PROGRAM AND AUTHORIZING THE EXECUTION OF ALL GRANT APPLICATION DOCUMENTS BY THE PUBLIC WORKS DIRECTOR OR DESIGNEE

WHEREAS, the Better Utilizing Investments to Leverage Development Program (BUILD) provides grant funds to eligible local agencies for the purpose of constructing infrastructure projects which support national and regional economic vitality goals; and

WHEREAS, the United States Department of Transportation administers BUILD and has requested applications from eligible agencies; and

WHEREAS, the Council certifies by resolution approval of submission of the application, program participation, the timeline for construction readiness and the availability of the required minimum matching funds; and

WHEREAS, the City of Fresno desires to apply for BUILD funding and enter into an agreement with the Department of Transportation for construction of the project.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. Approves the submission of the application for grant funding from the Better Utilizing Investments to Leverage Development Program for the project and participation therein consistent with constitutional and local law requirements and this resolution.
