A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE SUBMISSION OF AN APPLICATION FOR GRANT FUNDS FOR THE 2017-18 SUSTAINABLE TRANSPORTATION PLANNING GRANT PROGRAM FROM THE CALIFORNIA DEPARTMENT OF TRANSPORTATION AND AUTHORIZING THE EXECUTION OF APPLICATION RELATED DOCUMENTS BY THE PUBLIC WORKS DIRECTOR OR DESIGNEE

WHEREAS, the Sustainable Transportation Planning Grant Program provides grant funds for eligible local agencies for the purposes of identifying and addressing mobility deficiencies in the multimodal transportation system, encouraging stakeholder collaboration, involving active public engagement, and integrating Smart Mobility 2010 concepts which ultimately result in programmed system improvements; and

WHEREAS, the California Department of Transportation administers grant funding and has requested applications from eligible agencies for its 2017-18 call for projects; and

WHEREAS, the City of Fresno ("City") contemplates projects eligible for funding; and WHEREAS, the City desires to strategically plan future trail networks based on community input and an analysis of existing conditions; and

WHEREAS, the City will enter into an agreement with state of California for development of the projects; and

WHEREAS, the City demonstrates dedicated and available local matching funds;

NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF FRESNO HEREBY:

SECTION 1. Approves the application for grant funding from the Sustainable Transportation Planning Grant Sustainable Communities Program for the projects and participation therein consistent with constitutional and local law requirements and this resolution; and

SECTION 2. Certifies, consistent with constitutional and local law requirements and this resolution that the City has or will have sufficient funds to provide the minimum match and to operate and maintain the projects; and

SECTION 3. Certifies that the City has reviewed, understands and to the extent consistent with all constitutional and local law requirements and this resolution, agrees to the provisions contained in the application and program guidelines, manual and related documents; and

SECTION 4. Appoints and authorizes the Director of Public Works or designee, and each of them as agents for the City, to execute and submit all grant application related documents, subject to prior approval as to form by the City Attorney's Office.
