AN ORDINANCE OF THE CITY OF FRESNO,
CALIFORNIA, ADDING SECTION 105.6.49 TO CHAPTER
10, ARTICLE 5 OF THE FRESNO MUNICIPAL CODE
RELATING TO STORAGE OF TIRES

THE COUNCIL OF THE CITY OF FRESNO DOES ORDAIN AS FOLLOWS:

SECTION 1. Section 105.6.49 is added to Chapter 10, Article 5 of the Fresno Municipal
Code to read:


SECTION 105.6.49. STORAGE OF TIRES. Tires shall not be stored or
kept in violation of this section.

(a) Tires shall not be stored upon paved spaces designated for
parking vehicles, any driveway, or any public right of way.

(b) Tires shall not be stored within ten feet of a property line,
except within the interior of a building.

(c) Tires being displayed for sale on the exterior premises of a
building shall be placed within the interior of the building during the hours
the business is not open to the public; no more than twelve tires at one
time shall be displayed for sale on the exterior premises of a building at
any business location.

(d) Waste tires, as defined in Public Resources Code section
42950(l), shall be removed from the business location and properly
disposed of within thirty days from arrival at the business location.

(e) Tires stored on the exterior premises of a building shall not be stored within ten feet from any building, fence, wall, or other structure. Tire storage piles containing 500 or more waste tires shall be located at least 50 feet from lot lines and buildings.

(f) New and used tires stored or displayed on the exterior premises of a building shall be stored off the ground on racks or shelves.

(g) Any fence enclosing tires stored on the exterior premises of a building shall be opaque and of sufficient height (within limits allowed by this Code or permits applicable to the business) so the tires may not be observed by a person standing upon an adjacent property or right of way.

Violation of this section may be prosecuted as a misdemeanor and is subject to the City abating the offending conditions at the cost of the property owner and occupant.

SECTION 2. This Ordinance shall become effective and in full force and effect at 12:01 a.m. on the thirty-first day after its final passage.
