A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, TO APPROVE THE ISSUANCE OF THE CALIFORNIA STATEWIDE COMMUNITIES DEVELOPMENT AUTHORITY OF MULTIFAMILY HOUSING REVENUE BONDS FOR EL CAZADOR, LP IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED FIFTEEN MILLION DOLLARS (\$15,000,000) FOR THE PURPOSE OF FINANCING THE ACQUISITION, REHABILITATION, FURNISHING AND EQUIPPING OF EL CAZADOR APARTMENTS AND CERTAIN OTHER MATTERS RELATING THERETO

WHEREAS, El Cazador, LP (the "Borrower") has requested the California Statewide Communities Development Authority (the "Authority") adopt a plan of financing providing for the issuance of multifamily housing revenue bonds (the "Bonds") in one or more series issued from time to time, including bonds issued to refund such revenue bonds in one or more series from time to time, and at no time to exceed Fifteen Million Dollars (\$15,000,000) in aggregate principal amount, to finance the acquisition, rehabilitation, furnishing and equipping of a 100-unit multifamily rental housing project located at 4851 North Cedar Avenue, Fresno, California, generally known as El Cazador Apartments (the "Project") and operated by US Residential Group; and

WHEREAS, pursuant to Section 147(f) of the Internal Revenue Code of 1986 (the "Code"), the issuance of the Bonds by the Authority must be approved by the City of Fresno (the "City") because the Project is located within the territorial limits of the City; and

WHEREAS, the Council of the City of Fresno (the "Council") is the elected

legislative body of the City and is one of the applicable elected representatives required to approve the issuance of the Bonds under Section 147(f) of the Code; and

WHEREAS, the Council understands that its actions in holding the public hearing and in adopting this resolution do not obligate the City in any manner for payment of the principal, interest, fees, or any other costs associated with the issuance of the Bonds and the Council expressly conditions its approval of the issuance of the Bonds by the Authority by the adoption of this resolution on this understanding; and

WHEREAS, the Authority has requested the Council approve the issuance of the Bonds by the Authority in order to satisfy the public approval requirement of Section 147(f) of the Code and the requirement of Section 9 of the Amended and Restated Joint Exercise of Powers Agreement dated as of June 1, 1988, (the "Agreement"), among certain local agencies, including the City; and

WHEREAS, pursuant to Section 147(f) of the Code, the Council has, following notice duly given, held a public hearing regarding the issuance of the Bonds and now desires to approve the issuance of the Bonds by the Authority; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Council accepts the above recitals as true and correct.
2. The Council hereby approves the issuance of the Bonds by the Authority. It is the purpose and intent of the Council that this resolution constitute approval of the issuance of the Bonds by the Authority for the purposes of Section 147(f) of the Code by the applicable elected representative of the governmental unit having jurisdiction over the area in which the Facility is located, in accordance with said Section 147(f) of the Code and the requirement of Section 9 of the Agreement.
3. The officers and employees of the City are hereby authorized and directed, jointly and severally, to do any and all things and to execute and deliver any and all documents which they deem necessary or advisable in order to carry out, give

effect to, and comply with the terms and intent of this resolution and the financing transaction approved hereby.

4. This Resolution shall take effect immediately upon its adoption.
