BACKGROUND OF PROJECT (To be completed by Evaluating Department/Division. Explain need for project/equipment):

The Airport annually budgets for building maintenance and renovation projects as well as various unforeseen airport facility repairs. The proposed JOC Program will assist Airports in timely completion of these construction projects with improved quality at competitive rates to ensure FAT remains operationally ready and is properly positioned for local and regional growth.

The City may award up to three individual contracts for General Building Construction, one to each of the three lowest responsive bids, and up to two individual contracts for HVAC Construction, one to each of the two lowest responsive bids, but reserves the right to reject any and all bids, and waive any irregularities in any bid received.

DEPARTMENT CONCLUSIONS AND RECOMMENDATION:

- Award one General Building Construction Contract to each of the following three contractors: EXBON Development, Inc., Durham Construction, Puma Construction and one HVAC contract to each of the following two contractors: EXBON Development Inc., and Mesa Energy Systems, Inc.
