A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, DECLARING AN URGENT NECESSITY FOR THE PRESERVATION OF LIFE, HEALTH, OR PROPERTY; AUTHORIZING THE PLANNING & DEVELOPMENT DIRECTOR OR DESIGNEE TO ENTER INTO AGREEMENTS WITHOUT COMPETITIVE BIDDING FOR THE REHABILITATION OF UNITS AND REMOVAL OF HAZARDOUS MATERIALS; AND APPROVING A CONTRACT WITH OLSEN CONSTRUCTION FOR THE EMERGENCY RECONSTRUCTION OF UNITS AT THE EMERGENCY SHELTER FOR AN AMOUNT NOT TO EXCEED \$75,000.

WHEREAS, the City of Fresno (City) owns the property located at 933 N. Parkway, Fresno 93728 (APN: 449-335-32) known as Valley Inn (Property), which currently operates as a 106-unit Emergency Shelter; and

WHEREAS, twelve (12) units within the Property have sustained water damage, resulting in significant deterioration of the walls and other structural defects; and

WHEREAS, in July of 2024, the City Risk Department initiated emergency mold remediations by Olsen Construction by and through ALM Environmental and have since been completed with three (3) units remaining uninhabitable; and

WHEREAS, the condition of these three (3) units are unfinished and may pose an imminent danger to life, health, and safety; and

WHEREAS, immediate rehabilitation of the affected units is necessary to prevent further deterioration, mitigate risks to public safety, and preserve the integrity of the Property; and

WHEREAS, entering into agreements, without competitive bidding for various services, is necessary for the timely performance of the emergency repair work allowing for contractors to promptly perform demolition, hazardous material testing, and the removal of hazardous materials and debris without delay; and

WHEREAS, the City seeks to grant contracting authority to the Planning & Development Director or designee, allowing them to enter into an agreement with Olsen Constructions without competitive bidding, as necessary to ensure the timely completion of emergency repair work.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The foregoing facts constitute an urgent necessity for the preservation of life, health and property.
2. The requirement to advertise for competitive bids is hereby waived pursuant to Charter Section 1208(a).
3. The Planning & Development Director or designee is authorized to enter into a contract with Olsen Construction for demolition services, unit rehabilitation, hazardous materials testing, and the removal of hazardous materials and debris, for a term up to six months, with an amount not to exceed \$75,000, subject to prior approval as to form by the City Attorney's Office.
4. The Council finds the Project is in the best interest of the City.
5. This resolution shall be effective upon final approval.
