RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO,
CALIFORNIA, TO SUBMIT GRANT APPLICATIONS TO
CALIFORNIA DEPARTMENT OF TRANSPORTATION HIGHWAY
SAFETY IMPROVEMENT PROGRAM AND AUTHORIZING THE
EXECUTION OF DOCUMENTS BY THE PUBLIC WORKS
DIRECTOR OR DESIGNEE

WHEREAS, the Highway Safety Improvement Program provides grant funds to eligible local agencies for the purpose of safety improvements to public roads, public surface transportation facilities, publicly owned bicycle or pedestrian trails, and for traffic calming measures;

WHEREAS, the California Department of Transportation administers the grant program and has requested applications from eligible agencies for their Cycle 7 call for projects;

WHEREAS, the applicant's governing body certifies by resolution approval of the applications and program participation and the availability of the required minimum match;

WHEREAS, the City of Fresno will enter into an agreement with the State of California for development of the projects;

WHEREAS, the City of Fresno demonstrate dedicated and available local matching funds;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. Approves the application for and acceptance of grant funding from the Cycle 7 Highway Safety Improvement Program for the Projects and participation therein consistent with constitutional and local law requirements and this resolution;
2. Certifies, consistent with constitutional and local law requirements and this resolution that the City has or will have sufficient funds to provide the minimum match and to operate and maintain the projects;
