## RESOLUTION NO. 2015-242

A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, TERMINATING THE LOCAL STATE OF EMERGENCY

WHEREAS, Fresno Municipal Code Section 2-503 empowers the Mayor to proclaim the existence or threatened existence of a local emergency when the City is affected or likely to be affected by a public calamity and the Council is not in session; and

WHEREAS, the Mayor did find that conditions of extreme peril to the safety of persons and property arose within the City on November 23, 2015, due to nearly 1,100 tenants of the Summerset Village apartment complex being without heat and hot water due to a failed natural gas line; and

WHEREAS, the necessary repairs have been completed and the natural gas line is operational.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. Since the gas lines have been fixed within and around the Summerset Village Apartments and heat and hot water have been restored to the residents, the state of emergency throughout the City is no longer necessary, and is hereby terminated.

IT IS FURTHER PROCLAIMED AND ORDERED that a copy of this Resolution be forwarded to the Emergency Services Director of the County of Fresno, the State Director of the office of Emergency Services, and the Governor of California.
