## RESOLUTION NO. 2014-

A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE SUBMITALL OF A GRANT APPLICATION TO THE SAN JOAQUIN VALLEY AIR POLLUTION CONTROL DISTRICT AND ACCEPTANCE OF PUBLIC BENEFIT GRANT FUNDS AND EXECUTION OF NECESSARY PROGRAM DOCUMENTS

WHEREAS, the San Joaquin Valley Air Pollution Control District ("SJVAPCD") has authorized the establishment of the Public Benefit Grant Program ("Program") providing funds for the purchase of new alternative fuel vehicles;

WHEREAS, the Program assists public agencies with clean air alternative-fuel technologies and use of low- or zero-emission vehicles in public fleets;

WHEREAS, the use of alternative fuel vehicles assists the SJVAPCD in attaining federal and state air quality standards including the California Clean Air Act;

WHEREAS, said adopted procedures established by the SJVAPCD requires the applicant to certify by resolution the approval of the application prior to submission of said application;

WHEREAS, the proposed purchase of four (4) electric, and (2) Compressed Natural Gas, alternative fuel vehicles for the Parks, After School, Recreation and Community Services ("PARCS") Department is consistent with the Public Benefits Grant Program; and

WHEREAS, the purchase of the vehicles will impact motor vehicle emission reductions resulting in a long-term impact on air pollution in the City of Fresno and the San Joaquin Valley;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

- 1. Approves the filing of an application for the Public Benefit Grant Program.
- 2. Appoints the PARCS Department Director, or designee, as agent of the Applicant to conduct all negotiations and execute and submit all documents, including, but not limited to, applications, contracts, amendments, payment requests, and compliance with all applicable
