A RESOLUTION OF THE COUNCIL OF THE CITY OF  
FRESNO, CALIFORNIA, AUTHORIZING THE CREATION  
OF CONSTITUENT PARTICIPATION BUDGET  
COMMITTEES

WHEREAS, the City of Fresno Annual Budget is the most important document the City produces, outlining the City's spending plan and priorities for the coming fiscal year running from July 1 to June 30; and

WHEREAS, each year the City's budget is developed in conjunction with the Mayor, City Manager, and City departments, then reviewed and approved by the City Council; and

WHEREAS, the intended result is a budget that closely matches the community's highest priorities each fiscal year; and

WHEREAS, Councilmembers wish to have the option of soliciting input and participation from their constituency regarding the priority and needs of the City; and

WHEREAS, this Resolution will authorize each Councilmember to create a committee for that purpose; and

WHEREAS, input from the committee shall inform the Councilmember's consideration and adoption of the annual budget.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. Each Councilmember may create a Constituent Participation Budget Committee. The purpose of the committee is to advise the Councilmember as to needs

and priorities of the District and the City as a whole when considering the annual budget.

2. Each committee so created shall continue to exist until the FY 20 budget is adopted.

3. Each Councilmember may appoint as many residents to his or her committee as desired, and members shall serve at the pleasure of the Councilmember. Councilmembers shall submit the names of their appointees to the City Clerk.

4. Committee members shall not be compensated for their service. Committees shall be subject to the Brown Act, and members shall complete Form 700 Statements of Economic Interest.
