City Manager Rudd introduced the above item to Council.

The following member(s) of the public spoke on this item:

Blong Xiong, former Fresno City Councilmember; William Leifer, Legal Counsel for property owner Chris Henry; Zachary Darrah, Executive Director of Fresno Interdenominational Refugee Ministries ("FIRM"), and; Gary Jensen of Fresno Central Seventh Day Adventist Community Services.

City Attorney Sloan recommended the following change to the resolution authorizing the City Manager to contract for the repair of natural gal lines: delete the words "at a cost not to exceed \$_____" found at the end of numbered paragraph three.

Councilmember Olivier motioned to approve the item with the modified language suggested by City Attorney Sloan. Councilmember Brand seconded the motion.

President Baines asked Zachary Darrah of FIRM if his organization would try to determine if the families in the 41 units with interior gas leaks have relocated.

As suggested by other Councilmembers, President Baines directed City Manager Rudd to contact the lender to discuss habitability covenants that could be in the lending documents. President Baines directed City Manager Rudd to further evaluate the possibility of relocating residents with organizations such as FIRM and to report back to the Council with suggested actions the City could take to support such efforts.

President Baines directed City Manager Rudd to provide an updated timeline for repairs considering a best case and worst case scenario.
