This is an infill site that is in close proximity to water and sewer mains. The Zone District is RS-5 (Single Family Residential Medium Density).

Approval/Comment/Recommendations - Vesting Tentative Tract Map Application No. P24-02495 (VTTM-6429): Vesting Tentative Tract Map Application No. P24-02495 (VTTM-6429) was filed by Joseph Crown of Crown Homes and pertains to \pm 23.49 acres of property located at the southeast corner of West Ashlan and North Bryan Avenues. The applicant proposed to subdivide the property into 129 lots. The development will include 129 Single Family Detached home lots on approximately 23.49 acres for a density of 5.49 lots per acre in the RS-5 zone district. Lot sizes will range from 4,500 sq ft to 13,000 sq ft.
