BACKGROUND OF PROJECT (To be completed by Evaluating Department/Division. Explain need for project/equipment):

The Fresno-Clovis Regional Wastewater Reclamation Facility has approximately fifteen (15) miles of overhead medium voltage power lines supported by wooden electrical power supply poles, which are used to deliver electrical power supply to the reclamation wellfield and electrical appurtenances amongst the percolation basins. In 2016, an audit was conducted to determine the condition of the poles and identify those deteriorated poles in need of replacement. Based on the findings of that audit, the Department of Public Utilities has gradually replaced deteriorated electrical power supply poles since 2017. The forty-one (41) electrical power supply to be replaced through this Project are the last of deteriorated poles identified as needing replacement. Each of those deteriorated electrical power supply poles have surpassed their service life and are at high risk of causing electrical supply failure.
