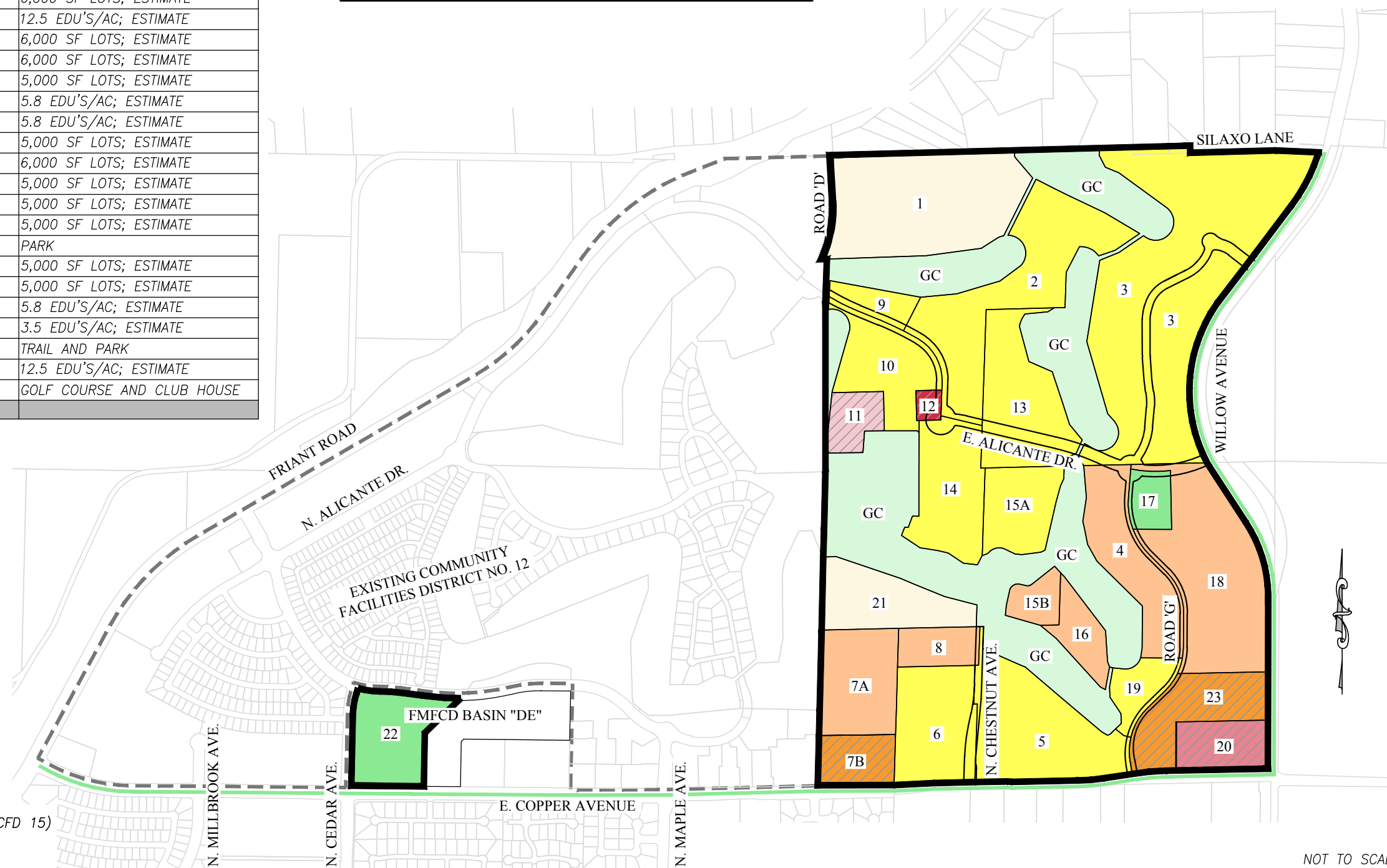

THE PROPERTY INCLUDES THE MEDIAN IN COPPER AVENUE FROM FRIANT AVENUE TO WILLOW AVENUE AND THE MEDIAN IN WILLOW AVENUE FROM COPPER AVENUE TO SILAXO LANE. THE PROPERTY ALSO INCLUDES THE LANDSCAPE AREAS BETWEEN THE STREET CURB AND THE PROPERTY LINE IN COPPER AVENUE FROM THE WEST BOUNDARY LINE TO WILLOW AVENUE AND WILLOW AVENUE FROM COPPER AVENUE TO SILAXO LANE.
