

FIRST AMENDMENT TO MEMORANDUM OF UNDERSTANDING

THIS FIRST AMENDMENT TO MEMORANDUM OF UNDERSTANDING ("Amendment") made and entered into as of this ____ day of October, 2016, amends the Memorandum of Understanding ("MOU") heretofore entered into between the CITY OF FRESNO, a municipal corporation ("CITY"), and CALIFORNIA STATE UNIVERSITY, FRESNO FOUNDATION, a California nonprofit public benefit corporation (hereinafter referred to as "CSUF").

RECITALS

WHEREAS, CITY and CSUF entered into an MOU, dated January 1, 2015, establishing Services to be performed by CSUF and Fresno Police Department as part of Project Safe Neighborhoods (hereinafter referred to as the "Program") funded by the United States Department of Justice ("DOJ") ("MOU"); and

WHEREAS, the MOU expired July 1, 2016; and

WHEREAS, CITY and CSUF now desire to extend the MOU for a one-year term.

AGREEMENT

NOW, THEREFORE, in consideration of the above recitals, which recitals are contractual in nature, the mutual premises herein contained, and for other good and valuable consideration hereby acknowledge, the parties agree that the aforesaid MOU be amended as follows:

1. The term of the MOU is amended to expire July 30, 2017.
2. The final invoice shall be submitted to CITY no later than June 1, 2017.
3. Except as otherwise provided herein, the MOU entered into by CITY and CSUF remains in full force and effect.


