A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, TO AUTHORIZE SUBMITTAL OF APPLICATION(S) FOR CALRECYCLE GRANTS IN CODE ENFORCEMENT, AND AUTHORIZE THE CITY ATTORNEY TO SIGN ON BEHALF OF THE CITY

WHEREAS, Public Resources Code sections 48000 et seq. authorize the Department of Resources Recycling and Recovery (CalRecycle) to administer various grant programs (Grants) in furtherance of the State of California's (State) efforts to reduce, recycle and reuse solid waste generated in the State thereby preserving landfill capacity and protecting public health and safety and the environment; and

WHEREAS, in furtherance of the authority CalRecycle is required to establish procedures governing the application, awarding, and management of the Grants; and

WHEREAS, CalRecycle grant application procedures require, among other things, an applicant's governing body to declare by resolution certain authorizations related to the administration of CalRecycle Grants; and

WHEREAS, if successful, the City of Fresno will enter into a grant agreement with CalRecycle for implementation of the Grants.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Council authorizes the submittal of applications to CalRecycle for the Local Government Waste Tire Enforcement, Waste Tire Cleanup, and Waste Tire Amnesty Grants.

2. Authorizes the City Attorney, or designee, subject to Council having

appropriated the necessary grant funds for this program, to execute in the name of the City of Fresno all grant documents, including but not limited to applications, agreements, amendments, and requests for payment, necessary to secure grant funds and implement the approved grant projects. All grant documents shall be approved as to form by the City Attorney's Office. The Council agrees that the authorization in this resolution shall continue in effect from the adoption of this resolution and for the duration of five years.
