## The findings of the Proposal Evaluation Committee are summarized as follows:

The Proposal Evaluation Committee applied the Sourcewell RFP evaluation criteria and determined that all proposal responses met the scope and mandatory submittal requirements and were evaluated.

Anchortex Corporation is a distributor of uniforms, footwear, accessories, and related products for over twenty-three manufacturers. They have a team of inside sales representatives ready to serve Sourcewell participating entities in the United States and Canada. Many of their products may be customized. Anchortex is small business certified by the State of New Jersey. They offer competitive pricing discounts off list pricing.

Blauer Manufacturing Company, Inc. manufactures a broad selection of uniforms including rainwear, gloves, footwear, and accessories, as well as a line of CBRN-protective uniform outerwear. Blauer maintains a field sales force in the United States and a nationwide distributor network in the United States and Canada. Distributors can perform in-house tailoring and customization services. They are offering favorable discounts off their published retail pricing to Sourcewell participating entities.

Courage Tactical LLC DBA CopsPlus a reseller of a full line of public safety apparel, uniforms, and footwear. Customization, personalization, alteration, fitting, and sizing services is also available. They have sales and customer support available to assist Sourcewell participating entities in the United States and Canada. Shipping charges are waived on orders over \$100. CopsPlus is offering a solid discount off MSRP pricing.

Galls, LLC is a distributor that specializes in uniforms, footwear, and equipment. With a dedicated sales and service team consisting of 205 representatives, 1500 dealer partners and operate 60 physical locations serving the United States and Canada. Services such as embroidery, tailoring, alterations, sample sizing runs, and in-store measurements are available. Galls provides a competitive discount off the published catalog prices.

LION First Responder PPE is a distributor of uniforms for first responders and public safety personnel. LION has over 200 distribution partners throughout the United States and Canada. Their products may be customized, including sizing, hemming, and post selection embellishments. They are offering substantial discounts to Sourcewell participating entities.

Municipal Emergency Services, Inc. is a national full-line first responder and public safety distributor in the United States and Canada. They offer top tier brands, uniform solutions, and customization. MES is supported by 200 sales representatives, 150 mobile uniform technicians, and inside sales staff and customer service. They provide manufacturer warranties and perform warranty service as an authorized repair center. MES is offering a discount off MSRP pricing to Sourcewell participating entities.

UniFirst Corporation provides uniforms and work apparel primarily through purchase and rental programs. They also provide various facility services products, such as floor mats, mops, wiping towels, and restroom products. Unifirst is offering a substantial discount to Sourcewell participating entities.

Vestis Uniforms and Workplace Supplies (Vestis) is offering a comprehensive line of uniforms and supplies, as well as a full-service uniform rental/lease program. They offer customization, alterations, mending and repair services. They have a team of over 20,000 sales and service associates ready to the United States and Canada. Vestis has made significant investments to the installation process and setup of uniform delivery services, ensuring continuous on-time delivery. Vestis is offering a favorable discount of off list price to Sourcewell participating entities.
