A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, ADOPTING AMENDMENT NO. 2015-002 TO THE FY 2014-2015 ANNUAL ACTION PLAN AUTHORIZING \$57,400 OF COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS FOR HOMELESS SERVICES AND \$150,000 FOR A LEAD HAZARD CONTROL PROGRAM FROM EXISTING APPROPRIATIONS FOR USE AS GRANT PROGRAM MATCH; ADOPTING THE PROJECT LOCATION LIST FOR STREET AND SIDEWALK IMPROVEMENTS IN THE CDBG-FUNDED NEIGHBORHOOD INFRASTRUCTURE PROGRAM; AND AUTHORIZING THE CITY MANAGER TO SIGN ALL IMPLEMENTING DOCUMENTS REQUIRED BY HUD

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) requires all jurisdictions that receive federal entitlement funds to prepare an Annual Action Plan, which identifies the projects to be funded with Community Development Block Grant (CDBG) Program Funds; and

WHEREAS, the City has previously adopted the FY 2014-2015 Annual Action Plan on June 19, 2014; and

WHEREAS, the proposed amendments are consistent with the five year Consolidated Plan which the City Council adopted on May 13, 2010; and

WHEREAS, the thirty-day public review and comment period concluded January 15, 2015; and

WHEREAS, the City desires to submit an amendment to its FY 2014-2015 Annual Action Plan to HUD to reflect changes in CDBG Homeless Services and Lead Hazard Control Programs (Attachment "A") and to adopt a project location list for street and sidewalk improvements in the CDGB-funded Neighborhood Infrastructure Program (Attachment "B").
