A RESOLUTION OF THE COUNCIL OF THE CITY OF
FRESNO, CALIFORNIA, DECLARING THE RESULTS OF
THE CONSOLIDATED GENERAL ELECTION HELD
WITHIN THE CITY OF FRESNO ON NOVEMBER 6, 2018

WHEREAS, on November 6, 2018, a general election was held in the City of Fresno, pursuant to Section 1400 of the Charter of the City of Fresno; and

WHEREAS, the Council met at the hour of 9:00 a.m. on December 6, 2018, at its usual meeting place to declare the results of such election; and

WHEREAS, the County Clerk of Fresno County has canvassed the returns of the general election; and

WHEREAS, the County Clerk of Fresno County has prepared and presented to the Council a certified abstract of canvassed returns setting forth the results of the election.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The certified statement of votes cast heretofore presented to this Council by the County Clerk of Fresno County is accepted and adopted as the official canvass of the returns of the November 6, 2018, general election held in the City of Fresno, and the Council finds, determines, and declares the results of the returns of the election as follows:

(a) The whole number of votes cast in the City, the names of the persons voted for, and for what office each person was voted for, are as set forth

in the attached certified abstract (Exhibit A), which is on file with the City Clerk and hereby made a part hereto as if fully set forth herein.

(b) MIGUEL ARIAS, having received the majority of votes cast for the office of Councilmember for District 3, is hereby declared elected to that office.

(c) LUIS CHAVEZ, having received the majority of votes cast for the office of Councilmember for District 5, is hereby declared elected to that office.

(d) NELSON ESPARZA, having received the majority of votes cast for the office of Councilmember for District 7, is hereby declared elected to that office.

(e) MEASURE A, regarding a new Cannabis Business License Tax, received at least two-thirds of the votes cast citywide and passed.

(f) MEASURE O, regarding technical charter cleanup, received less than a majority of the votes cast citywide, and failed.

(g) MEASURE P, regarding a proposed Fresno Clean and Safe Neighborhood Parks Tax Ordinance received less than two-thirds of the votes cast citywide, and failed.

(h) MEASURE Q, regarding a balanced budget amendment to the Charter received a majority of the votes cast citywide and passed.
