A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING DISSOLUTION OF THE IMMIGRANT AND RESIDENT AFFAIRS COMMITTEE AND TRANSITION TO A CITY/COUNTY IMMIGRANT AFFAIRS WORKING GROUP

WHEREAS, Councilmember Miguel Arias and former Councilmember Luis Chavez sponsored Resolution 2019-028 in February of 2019 which created the Immigrant and Resident Affairs Committee (Committee); and

WHEREAS, the City recognizes the foundational contributions of immigrants to all aspects of the City, including business, civic groups, the agricultural industry, faith based organizations and community institutions; and

WHEREAS, Council Vice President Miguel Arias and Fresno County Supervisor Luis Chavez intend to lead the City and County in formation of a City/County Immigrant Affairs Working Group which will include community, business and civic leaders; and

WHEREAS, upon creation by the City and County, a City/County Immigrant Affairs Working Group will facilitate the City and County's collaboration in support of Fresno's diverse immigrant community; and

WHEREAS, the Fresno City Council Rules of Procedure allow for the creation and dissolution of committees at the discretion of the City Council.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Immigrant and Resident Affairs Committee is hereby dissolved.
2. This resolution shall be effective upon approval.
