# AMENDMENT NO. 1\_ TO COOPERATIVE PROJECT AGREEMENT Short-Term Regional Transportation Program (STRTP) Urban Project I2D – Peach Avenue Church to Jensen

This Amendment No. 1 to STRTP Project, is made and entered into the \_\_\_ day of \_\_\_\_\_\_, 2025 by and between the Fresno County Transportation Authority ("Authority") and the City of Fresno ("Responsible Agency").

1. <u>PARTIES</u>. The Authority and the City of Fresno are collectively referred to herein as "the Parties".

# 2. RECITALS.

2.1 WHEREAS, the Parties entered into the Cooperative Project Agreement for **I2D Urban**, **Peach Avenue Church to Jensen** ("Agreement"), dated **February 1, 2024**, for funding of a transportation improvement project ("**Project**") in Fresno County pursuant to the Measure "C" Strategic Implementation Plan ("**SIP**"), and the Fresno County Measure "C" Expenditure Plan ("**Expenditure Plan**"), which was approved by the voters of Fresno County in November, 2006; and,

WHEREAS, the agreement provided that Authority shall provide funding to the Responsible Agency for eligible Phase 1 (Preliminary Engineering) Project costs in an amount "not-to-exceed" \$234,720 of Measure C funds; and

WHEREAS, Authority is authorized to approve and revise Project funding for payment to Responsible Agency in accordance with the **Agreement**, the Strategic Implementation Plan (SIP) and the Expenditure Plan regarding the Project **I2D Urban**, **Peach Avenue Church to Jensen**; and,

- 2.2 The Parties now desire to amend the statements defining and delineating the Project Scope, Project Schedule and Project Funding Program, as set forth in the original Agreement, based on the following:
  - Responsible Agency desires to amend the funding allocation for the Project per the revised Exhibits as more thoroughly described in Section 3.1 of this Amendment. This increases the total funding amount to \$838,720 authorized by the original Agreement, as previously modified.
  - It is the intent of the Parties that, as result of the funding allocation provided for herein, the Measure C funding for this Project in the not-to-exceed cumulative amount of \$838,720, shall be allocated among the Phases of the Project as follows: \$234,720 to Preliminary Engineering and \$604,000 to Right of Way Acquisition for Project per the revised Exhibits as more thoroughly described in Section 3.1 of this Amendment No. 1.

# 3. TERMS.

- 3.1 Exhibit "A" (Project Scope), Exhibit "B" (Project Schedule) and Exhibit "C" (Project Funding Program), which hereinafter shall be referenced collectively the "Original Exhibits" as set forth in Section 1.1 of the original Agreement, and which were fully incorporated therein by the provisions of Section 3.23 thereof, shall be and are hereby replaced by Exhibit "A1" (Project Scope), Exhibit "B1" (Project Schedule), and Exhibit "C1" (Project Funding Program), which are attached hereto and incorporated herein by this reference, commencing upon the Effective Date of this Amendment No. 1 to the Agreement.
- 3.2 All work performed by the Responsible Agency under the **Agreement** prior to the Effective Date of this **Amendment No. 1** shall be governed by and compensated pursuant to the applicable Exhibits and the original **Agreement**, as modified by the previously approved amendment thereto. All work commencing on or after the Effective Date of this **Amendment No. 1** shall be performed and compensated pursuant to the attached Exhibits A1, B1 and C2, and the terms of the **Agreement** as modified by this **Amendment No. 1**.
- 3.3 <u>Effective Date</u>. The Effective Date of this **Amendment No.1** to the Agreement shall be 12:01 a.m. of the day following the date upon which it is signed by the Parties. In the event this **Amendment No. 1** to the Agreement is signed by the Parties on different dates, the Effective Date shall be 12:01 a.m. of the day following that date upon which it is signed by the second of the Parties.
- 3.4 All other terms and conditions contained in the Cooperative Project Agreement are unaffected by this **Amendment No. 1** and shall remain in full force and effect.

Phase 1 includes preliminary design/engineering (PS&E) and environmental review and approval of the preliminary environmental study (CEQA). ROW acquisition will start after approval of the preliminary environmental study (CEQA).

The project will widen Peach Ave from Florence to Church Avenue approximately 0.5 miles. from two lanes to a divided four-lane arterial, featuring median landscaping, protected left-turn lanes, bike lanes, curb and gutter, sidewalks, landscaping and irrigation, streetlights, and modifications to existing traffic signal facilities at Church and Jensen. Additionally, it includes the installation of FMFCD facilities and the construction of a temporary drainage basin. Phase 1 includes preliminary design/engineering (PS&E) and environmental documents to comply with CEQA requirements, and preparation of contract construction documents including engineer's estimates for construction.

# **Project Purpose**

The purpose of this project is to provide for improved mobility by increasing capacity along Peach Avenue between Church Avenue and Jensen Avenue.

## **Transportation Benefit**

The project is expected to improve air quality, reduce traffic congestion thereby improving travel time, and motorist and pedestrian safety.

### **Implications of Not Doing the Project**

It was determined in various traffic studies that the existing number of travel lanes along Peach Avenue will not be sufficient to accommodate the traffic demands in the Year 2030. According to the traffic study conducted by VRPA, the expected volume along the Project in the Year 2030 will be 22,400 vehicles per day. Based on the projected future volumes, without the Project, the Level of Service (LOS) is expected to be LOS "F". With the Project, the expected LOS is projected to be LOS "B".

#### **Community Engagement**

The project limits are within a moderately populated residential area. Residents, businesses and property owners will be kept informed of the Project's status and schedule through Project newsletters, the City's website and local media.

#### **Construction Staging**

Construction phasing may be implemented due to the potential impacts on adjacent residences, businesses, schools, which use these streets to access their property.

#### **Detours**

During construction of this Project, traffic will be routed to north/south arterials Willow and Clovis Avenues, and east/west arterials Butler and North Avenues. Access to residences, businesses, and schools adjacent to Peach Avenue will be provided and maintained throughout construction.

# **Current Status**

The Environmental portion of Phase 1 is complete/pending approval, and we are currently into the 90 percent design phase for this project. Phase 2 will begin after approval of this amendment. Phase 3 construction will be initiated after completion of Phase 2 and relocation of existing utilities by PG&E.
