



Public Notice Hearing Radius Map (1,000 ft)

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Fresno CITY COUNCIL, in accordance with Sections 65090 and 65091 (Planning and Zoning Law) of the Government Code and in accordance with the procedures of Article 50, Chapter 15, of the Fresno Municipal Code (FMC), will conduct a public hearing to consider an appeal of the items below, filed by Jamie Huelskamp of Park 7, LLC pertaining to approximately 3.7 acres of property located at 7056 North Prospect Avenue, on the northeast corner of West Herndon and North Prospect Avenues:

- 1. **Environmental Assessment No. P21-00989**: A determination that the proposed project is exempt from the California Environmental Quality Act (CEQA) through a Section 15332/Class 32 Categorical Exemption dated February 9, 2024.
- 2. **Development Permit Application No. P21-00989:** A request for authorization to construct an 82-unit multi-unit residential development, including three (3) three-story buildings and one (1) four-story building.

If you challenge the above application(s) in court, you may be limited to raising only those issues, you, or someone else, raised at the public hearing described in this notice, or in written correspondence delivered to the Development Services Division of the Planning and Development Department and/or City Council at, or prior to, the public hearing. The Fresno City Planning Commission considered this application at its meeting on May 15, 2024, and voted to recommend denial.

NOTE: This public hearing notice is being sent to surrounding property owners within 1,000 feet of the project site pursuant to the requirements of FMC Section 15-5007.
