A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, TO APPROVE THE ISSUANCE OF THE CALIFORNIA AFFORDABLE HOUSING AGENCY OF MULTIFAMILY HOUSING REVENUE BONDS FOR DHI KING'S VIEW ASSOCIATES, LP IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED NINE MILLION TWO HUNDRED AND FIFTY THOUSAND DOLLARS (\$9,250,000) FOR THE PURPOSE OF FINANCING THE ACQUISITION, REHABILITATION, IMPROVEMENT AND EQUIPPING OF KING'S VIEW ESTATES AND CERTAIN OTHER MATTERS RELATING THERETO

WHEREAS, DHI King's View Associates, LP (the "Borrower") has requested the California Affordable Housing Agency (the "Agency") adopt a plan of financing providing for the issuance of multifamily housing revenue bonds (the "Bonds") in one or more series issued from time to time, including bonds issued to refund such revenue bonds in one or more series from time to time, and at no time to exceed nine million two hundred and fifty thousand dollars (\$9,250,000) in aggregate principal amount, to finance the acquisition, rehabilitation, improvement and equipping of a 116-unit multifamily rental housing project located at 2705 Martin Luther King Jr Boulevard, Fresno, California, generally known as King's View Estates (the "Project") and operated by the Borrower; and

WHEREAS, pursuant to Section 147(f) of the Internal Revenue Code of 1986 (the "Code"), the issuance of the Bonds by the Agency must be approved by the City of Fresno (the "City") because the Project is located within the territorial limits of the City; and

WHEREAS, the Council of the City of Fresno (the "Council") is the elected legislative body of the City and is one of the applicable elected representatives required to approve the issuance of the Bonds under Section 147(f) of the Code; and

WHEREAS, the Council understands that its actions in holding the public hearing and in adopting this resolution do not obligate the City in any manner for payment of the principal, interest, fees, or any other costs associated with the issuance of the Bonds and the Council expressly conditions its approval of the issuance of the Bonds by the Agency by the adoption of this resolution on this understanding; and

WHEREAS, the Agency has requested the Council approve the issuance of the Bonds by the Agency in order to satisfy the public approval requirement of Section 147(f) of the Code; and

WHEREAS, pursuant to Section 147(f) of the Code, the Council has, following notice duly given, held a public hearing regarding the issuance of the Bonds and now desires to approve the issuance of the Bonds by the Agency; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Council accepts the above recitals as true and correct.
2. The Council hereby approves the issuance of the Bonds by the Agency. It is the purpose and intent of the Council that this resolution constitute approval of the issuance of the Bonds by the Agency for the purposes of (a) Section 147(f) of the Code by the applicable elected representative of the governmental unit having jurisdiction over the area in which the Project is located, in accordance with said Section 147(f) of the Code.
3. The officers and employees of the City are hereby authorized and directed, jointly and severally, to do any and all things and to execute and deliver any and all documents which they deem necessary or advisable in order to carry out, give effect to, and comply with the terms and intent of this resolution and the financing transaction approved hereby.

4. This Resolution shall take effect immediately upon its adoption.
