The Engineer's Estimate for this expenditure is \$600,000. The contract price is 16% below the Engineer's Estimate.

BACKGROUND OF PROJECT:

In 2014 it was brought to DPU/Wastewater Management Department (WMD) attention that a new commercial development will be developed on the southwest corner of the Manchester Center Mall. This new development will complicate access to the sewer when the City needs to perform maintenance or repairs in the future. To avoid this issue, WMD requested sewer maintenance to go out and evaluate the existing pipe using closed circuit television (CCTV). The evaluation shows extensive signs of hydrogen sulfide corrosion to the concrete to the point of exposing the reinforcing steel, and two necessary point repairs. The rehabilitation of these sewer mains begins at Manhole 2056-21 in the Starbucks and Panda Express parking lot in Manchester Center and ends at Manhole 2055-24 in E. Garland Avenue just east of N. Blackstone Avenue. DPU recommends installing a corrosion resistant liner in the existing concrete pipe as the most cost effective solution. Additionally DPU recommends the rehabilitation of all the manholes by coating the manholes with an epoxy coating. The corrosion resistant liner and the manhole coating will restore the structural integrity and prevent further deterioration caused by hydrogen sulfide.
